RESOLUTION NO. 893-2020

DECLARING MUNICIPAL ORDINANCE NO. 08, S-2020 OF THE SANGGUNIANG BAYAN OF BAYAMBANG, PANGASINAN, ENTITLED "AN ORDINANCE AMENDING SECTION 11 PARAGRAPH (b) OTHERWISE KNOWN AS "AN ORDINANCE ADOPTING A PUBLIC-PRIVATE PARTNERSHIP FOR THE PEOPLE INITIATIVE FOR LOCAL GOVERNMENT (LGU P4), PROVIDING FOR THE PROCEDURE FOR SELECTING THE PRIVATE SECTOR PROPONENT AND ADOPTING A CONTRACT MANAGEMENT FRAMEWORK IN THE MUNICIPALITY OF BAYAMBANG" AS WITHIN THE CONFERRED POWER OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Bayambang, Pangasinan submitted its Municipal Ordinance No. 08, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the power of the local legislative bodies to enact ordinances includes the power to amend, revoke or repeal the same pursuant to Section 17 (a), (j), (g), and Section 22 (d) of RA 7160;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject municipal ordinance in order;

WHEREFORE, in view of the foregoing, on motion of SP Members Vici M. Ventanilla and Angel M. Baniqued, Jr. and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –

"ORDINANCE AMENDING SECTION 11 PARAGRAPH (b) OTHERWISE KNOWN AS "AN ORDINANCE ADOPTING A PUBLIC-PRIVATE PARTNERSHIP FOR THE PEOPLE INITIATIVE FOR LOCAL GOVERNMENT (LGU P4), PROVIDING FOR THE PROCEDURE FOR SELECTING THE PRIVATE SECTOR PROPONENT AND ADOPTING A CONTRACT MANAGEMENT FRAMEWORK, IN THE MUNICIPALITY OF BAYAMBANG"

Be it enacted by the Sangguniang Bayan in session assembled that:

Section 1. Section 11 Paragraph (b) of the Municipal Ordinance No. 8, Series of 2018 shall be read as follows:

SECTION 11. General Requirements. - These are the general requirements for the Municipality of Bayambang in entering into LGU P4:

(b) The approval of projects proposed under this Act shall be in accordance with the following:

1. National Projects - The projects must be part of the Agency's development programs, and shall be approved as follows:

- i. projects costing up to Php300 million, shall be submitted to ICC for approval;
- ii. projects costing more than Php 300 million, shall be submitted to the NEDA Board for approval upon the recommendation of ICC.; and
- iii. regardless of amount, negotiated projects shall be submitted to the NEDA Board for approval upon recommendation by the ICC.

2. Local Projects - Local projects to be implemented by the LGUs shall be submitted by the concerned LGU for confirmation, as follows:

- i. to the municipal development council for projects costing up to Php20 million;
- ii. to the provincial development council for those costing above Php20 million up to Php 50 million;
- iii. to the regional development council for those costing above Php 50 million up to Php 200 million; and
- iv. to the ICC for those costing above Php 200 million.

Final approval of projects classified under b.i to b.iv of this section is vested on the Local Sanggunians per provisions of the Local Government Code.

Section 2. SEPARABILITY CLAUSE - It is the Sanggunian's intent if any section, subsection, clause or provision of this ordinance is deemed invalid or unconstitutional by a court of competent jurisdiction, such portion will become a separate provision and will not affect the remaining provisions of this ordinance. The Sanggunian further declares its intent that these provisions of this ordinance would have been adopted if unconditional provision was not included.

Section 3. REPEALING CLAUSE - All local ordinances, resolutions, orders, rules and regulations that are inconsistent with this Ordinance are hereby repealed, modified or amended accordingly.


Section 4. EFFECTIVITY CLAUSE - This Ordinance shall take effect upon approval and compliance with the posting and publication requirements.
