**WHEREAS**, on the basis of the said request the Bids and Awards Committee caused the publication of the advertisement for the Invitation to Bid in Phil-GEPS website ([www.philgeps.gov.ph](http://www.philgeps.gov.ph)) on **FEBRUARY 26, 2021**, which was created on **FEBRUARY 24, 2021**, continuously for seven (7) calendar days;

**WHEREAS**, in response to the said advertisement, *three bidders* expressed their interest in participating in the procurement process of the **SUPPLY DELIVERY OF CONSTRUCTION MATERIALS FOR FARM TO MARKET ROAD AT BRGY. BACNONO**;

**WHEREAS**, on **March 17, 2021** the Opening of Bids was conducted at the Bayambang Events Center, Bayambang, Pangasinan and upon careful examination and checking of bid validity, the Bids and Awards Committee declared **TRI SAPPHIRE BLUE SKY COMMERCIAL INC.** "COMPLYING".

**WHEREAS**, **TRI SAPPHIRE BLUE SKY COMMERCIAL INC.** bid As Read was **TWO HUNDRED SEVENTY FOUR THOUSAND FOUR HUNDRED THIRTEEN PESOS (274,413.00) ONLY.**
