**KNOW ALL MEN BY THESE PRESENTS:**


**THIS AGREEMENT** made this 14<sup>th</sup> day of **April 2021** between the Local Government Unit of Bayambang, Pangasinan, Philippines (hereinafter called "The Entity") of the one part **TRI SAPPHIRE BLUE SKY COMMERCIAL INC.** of **01 Governor Sison Street, Poblacion, Lingayen, Pangasinan** (hereinafter called "The Contractor") of the part:


**WHEREAS**, the MUNICIPALITY OF BAYAMBANG is desirous that **TRI SAPPHIRE BLUE SKY COMMERCIAL INC.** execute the **SUPPLY DELIVERY OF CONSTRUCTION MATERIALS FOR ROAD WIDENING/ SIDEWALK AT BRGY. SAPANG** (hereinafter called "The Works") and the Municipality of Bayambang has accepted the Bid for Pesos: **Three Hundred Three Thousand Three Hundred Thirty Five Pesos and 50/100 (PhP 303,335.50) Only** (hereinafter called "The Contract Price").

**NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:**


1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to;
2. The following documents shall be attached, deemed to form, be read and construed as part of this Agreement, to wit:
  - a) General & Special Conditions of Contract;
  - b) Technical Specifications;
  - c) Invitation to Bid;
  - d) Instruction to Bidders;
  - e) Bid Data Sheet;
  - f) Bid Form, including all the documents/statements contained in the Bidder's Bidding envelopes, as annexes;
  - g) Eligibility requirements, documents and/or statements;
  - h) Notice of Award of Contract and the Bidder's conformed thereto;
  - i) Other Contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Municipality of Bayambang **TRI SAPPHIRE BLUE SKY COMMERCIAL INC.** of **01 GOVERNOR SISON STREET, POBLACION, LINGAYEN, PANGASINAN** hereinafter mentioned, **TRI SAPPHIRE BLUE SKY COMMERCIAL INC.**, hereby covenants with the Municipality of Bayambang, Pangasinan to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
4. The Municipality of Bayambang hereby covenants to pay **TRI SAPPHIRE BLUE SKY COMMERCIAL INC.** of **01 GOVERNOR SISON STREET, POBLACION, LINGAYEN, PANGASINAN** in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.


