The Government of the Philippines (GoP) has received a Loan from the World Bank towards the cost of Philippine Rural Development Program and it intends to apply part of the proceeds of this Loan to payments under the contract for the **Improvement of San Gabriel II Farm to Market Road with Bridge / PRDP-IB-R001-PAN-006-BAY-001-2018-AF**
2. The **Municipal Government of Bayambang, Pangasinan**, implementing partner of the Department of Agriculture, now invites bids for the **Improvement of San Gabriel II Farm to Market Road with Bridge**. Completion of the Works is required by **450** calendar days. Bidders should have completed, within the last five (5) years, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
3. Bidding will be conducted in accordance with relevant procedures for open competitive bidding as specified in the IRR of RA 9184 (R.A. 9184), with some amendments, as stated in these bidding documents and is open to all bidders from eligible source countries as defined in the applicable procurement guidelines of the World Bank. The contract shall be *awarded to the Lowest Calculated Responsive Bidder (LCRB) who was determined as such during post-qualification. The Estimated Project Cost for this project is **One Hundred Twenty-Six Million Four Hundred Seventy-Eight Thousand Pesos (PhP126,478,000.00)**.*
4. Interested bidders may obtain further information from the Bids and Awards Committee of the **Municipal Government of Bayambang, Pangasinan** and inspect the Bidding Documents at the address given below and also at the PRDP Regional Project Coordination Office I with address at DA RFO I, Capitol Compound, Aguila Road, Sevilla, San Fernando City, La Union and at the PRDP Project Support Office North Luzon with address at Capitol Compound, Sto. Niño, City of San Fernando, Pampanga from **8:00 a.m. to 5:00 p.m.**, Mondays to Fridays.
5. A complete set of Bidding Documents may be purchased by interested Bidders starting **December 20, 2021** from the Bids and Awards Committee of **Municipality of Bayambang** with address below, PRDP RPCO I or PRDP PSO North Luzon and upon payment or



depositing / bank transfer to **Municipal Government of Bayambang, Pangasinan Landbank Trust Fund – Account Number 1342-1025-96** a non-refundable fee for the bidding documents in the amount of **Ten Thousand Pesos (PhP10,000.00) not later than the submission of their bids.** The LGU Treasurer's official receipt, the bank teller's validated deposit slip or printed receipt from online payment the proof of payment serves as the proof of payment.

Online payment shall mean payment using the likes of PayMaya, IAccess, Smart Money, GCash, DragonPay, JuanPay, PesoPay, PayEasy, MOLPay, WeePay, 7 Connect, Coins.ph.



The DA, however, requires that all potential contractors who will be awarded contract under the project shall have undergone geotagging training provided by the PRDP Project Support Office.

6. The Municipal Government of Bayambang, Pangasinan will hold a **Pre-Bid Conference on January 4, 2022 at 10:00 a.m. at Bayambang Events Center, Bayambang, Pangasinan** which shall be open to all interested parties.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **January 19, 2022, 10:00 a.m.** All Bids must be accompanied by a **Bid Securing Declaration.**

Bids will be opened on **January 19, 2022, 10:00 a.m.** at the **Bayambang Events Center, Bayambang, Pangasinan.** Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted
