

**.. Contract of Agreement ..**

**KNOW ALL MEN BY THESE PRESENTS:**

**THIS AGREEMENT** made this 12<sup>th</sup> day of **November 2021** between the Local Government Unit of Bayambang, Pangasinan, Philippines (hereinafter called "The Entity") of the one part **ADROIT CONSTRUCTION** of **Ben Saturno Avenue, Brgy. Sibut, San Jose City, Nueva Ecija** (hereinafter called "The Contractor") of the part:

**WHEREAS**, the MUNICIPALITY OF BAYAMBANG is desirous that **ADROIT CONSTRUCTION** to execute the **CONSTRUCTION OF CORE LOCAL ACCESS ROAD** (hereinafter called "The Works") and the Municipality of Bayambang has accepted the Bid for Pesos: **TWO MILLION THREE HUNDRED THOUSAND PESOS (PHP 2,300,000.00) ONLY** (hereinafter called "The Contract Price").

**NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:**

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to;
2. The following documents shall be attached, deemed to form, be read and construed as part of this Agreement, to wit:
  - a) General & Special Conditions of Contract;
  - b) Technical Specifications;
  - c) Invitation to Bid;
  - d) Instruction to Bidders;
  - e) Bid Data Sheet;
  - f) Bid Form, including all the documents/statements contained in the Bidder's Bidding envelopes, as annexes;
  - g) Eligibility requirements, documents and/or statements;
  - h) Notice of Award of Contract and the Bidder's conformed thereto;
  - i) Other Contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Municipality of Bayambang **ADROIT CONSTRUCTION** of **Ben Saturno Avenue, Brgy. Sibut, San Jose City, Nueva Ecija** hereinafter mentioned, **ADROIT CONSTRUCTION**, hereby covenants with the Municipality of Bayambang, Pangasinan to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
4. The Municipality of Bayambang hereby covenants to pay **ADROIT CONSTRUCTION** of **Ben Saturno Avenue, Brgy. Sibut, San Jose City, Nueva Ecija** in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
