MUNICIPAL ORDINANCE NO. <u>14</u>, SERIES of 2021

AN ORDINANCE PROHIBITING THE SALE, DISTRIBUTION OR ADMINISTRATION OF COVID-19 VACCINES FOR GAIN, INCOME OR PROFIT IN MUNICIPALITY OF BAYAMBANG, WITHOUT FULL MARKET AUTHORIZATION ISSUED BY THE FOOD AND DRUG ADMINISTRATION, AND PROVIDING PENALTIES THEREFOR"

BE IT ENACTED by the Sangguniang Bayan of Bayambang, in session assembled that:

SECTION 1. TITLE – This ordinance shall be known as the "Illegal Sale of Covid-19 Vaccine Ordinance of Municipality of Bayambang"

SECTION 2. COVERAGE – This Ordinance shall cover all persons (natural or juridical) within the territorial jurisdiction of the Municipal of Bayambang.

SECTION 3. PROHIBITION – While the country is in state of public health emergency, it shall be unlawful for any person (natural or juridical) to engage in the sale, distribution or administration of COVID-19 vaccines for gain, income or profit, without full market authorization issued by the Food and Drug Administration.

Further, it shall be unlawful for any person to sell vaccination slot or appointment, directly or indirectly, such as by texting, calling, chatting or thru any other social media platforms, to any person not officially registered in any of the vaccination centers in Municipality of Bayambang.

SECTION 4. IMPLEMENTATION – This Ordinance shall be implemented by the Municipal Health Office, Bayambang Municipal Police Office, Punong Barangays and their authorized personnel, and authorized personnel deputized by the Local Chief Executive.

SECTION 5. PENALTY CLAUSE – Any person or business establishment violating any of the provision of Section 3 shall be penalized by:

- i. First Offense: Fine of One Thousand Pesos (Php 1,000.00) or imprisonment of ten (10) days or both such fine and imprisonment at the discretion of the court;
- ii. **Second Offense**: Fine of One Thousand Five Hundred Pesos (Php 1, 500.00) or imprisonment of twenty (20) days or both such fine and imprisonment at the discretion of the court;
- iii. Third and Succeeding Offenses: Fine of Two Thousand Five Hundred Pesos (Php 2,500.00) and imprisonment of not more than one (1) month or both such fine and imprisonment at the discretion of the court.

If the violation is committed by a corporation or other juridical entity, the director, officer, employee or other officers responsible for the violation shall be charged and penalized. In addition, thereto, the business license issued to the said person, corporation or the other juridical entity shall be immediately revoked and shall be banned from doing business in the Municipality of Bayambang.

Furthermore, if the violation is committed by a minor, the parents or guardian or person responsible for the minor shall be charged and penalized.

SECTION 6. NO CONTEST PROVISION. Any person apprehended for violation of this Ordinance who does not wish to contest the violation and is willing to pay voluntarily the penalty imposed upon him/her prior to the filing of formal complaint shall be allowed to pay said fine with the Treasurer's Office to avoid being prosecuted. If the violator has already availed of the No Contest Provision three (3) times, he/she can no longer avail of the same and the corresponding complaint for the violation of the Ordinance, with the maximum penalty imposed should be filed against the violator.

The violator shall be given five (5) calendar days from issuance of the Ordinance Violation eceipt within which to pay the fine.

SECTION 7. SEPARABILITY CLAUSE. – If for any reason or reasons, any part or parts or provisions of this Ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 8. REPEALING CLAUSE. – All ordinances, resolutions, circulars, memoranda, or rules and regulations, inconsistent with the provisions of this Code are hereby repealed or modified accordingly.

SECTION 9. EFFECTIVITY CLAUSE. This Ordinance shall take effect upon approval and compliance with the publication requirements.
