WHEREAS, the Municipality of Bayambang, Pangasinan will celebrate its 409th Foundation Anniversary and Annual Town Fiesta Celebration beginning March 27, 2023 to April 2, 2023 with a weeklong socioeconomic-cultural festivities;

WHEREAS, due to several activities in line with the celebration of the forthcoming 409th Foundation Day and Town Fiesta, there is a need to temporarily close certain portion of municipality streets and to serve as venue for the scheduled activities on certain dates;

WHEREAS, the temporary closure of the roads is to provide our participants, visitors and guests a space for parking areas and minimized traffic congestion in order not to unduly inconvenience the public;

WHEREAS, a comprehensive and integrated, traffic management plan, safety and security, and health and sanitation including the site plan and layout for the conduct of the "Town's Founding Anniversary and Annual Town Fiesta was submitted by the Bayambang Public Safety Office (BPSO) to this Office;

WHEREAS, the subject ordinance was enacted pursuant to Section 21 of the Local Government Code of 1991 and Article 43 of its Implementing Rules and Regulations, to wit:

Sec. 21. Closure and Opening of Roads. (a) A local government unit may, pursuant to an ordinance, permanently or temporarily close or open any local road, alley, park, or square falling within its jurisdiction; Provided, however, that in case of permanent closure, such ordinance must be approved by at least two-thirds (2/3) of all the members of the sanggunian, and when necessary, an adequate substitute for the public facility that is subject to closure is provided. xxx

(c) Any national or local road, alley, park, or square may be temporarily closed during an actual emergency, or fiesta celebrations, public rallies, agricultural or industrial fairs, or an undertaking of public works and highways, telecommunications, and waterworks projects, the duration of which shall be specified by the local one fexecutive concerned in a written order: Provided, however, That no national or local road, alley park, or square shall be temporarily closed for athletic, cultural, or civic activities not officially sponsored, recognized, or approved by the local government unit concerned.

(d) Any city, municipality, or barangay may, by a duly enacted ordinance, temporarily close and regulate the use of any local street, road, thoroughfare, or any other public place where shopping malls, Sunday, flea or night markets, or shopping areas may be established and where goods, merchandise, foodstuffs, commodities, or articles of commerce may be sold and dispensed to the general public; and

WHEREAS, the Implementing Rules of the said law also provides that:

"Article 43. Authority to close or open. An LGU may, through an ordinance, permanently or temporarily close or open any road, park or square within its jurisdiction".

NOW THEREFORE, on motion of SB Member Amory M. Junio, duly seconded;

Be it enacted by the Sangguniang Bayan in session assembled, that:

SECTION 1. SCOPE AND LIMITATION. THE HALF LANE PORTION OF THE NATIONAL ROAD STARTING FROM SAINT VINCENT PRAYER PARK, TRAVERSING TO BRGY. BANI, BRGY. ZONE VII, AND ZONE III, PORTION OF RIZAL AVENUE, WHOLE LAND OF ROXAS ST., AND QUEZON BLVD. FROM 5:00 O'CLOCK IN THE MORNING TILL 12:00 O'CLOCK NOON OF MARCH 27, 2023 FOR THE GRAND OPENING, MOTORCADE AND STREETDANCING COMPETITION, PORTION OF RIZAL AVENUE, ROXAS ST. AND QUEZON BLVD. SECTION 2. The following terms and conditions shall be implemented:

- a) That a substitute route with corresponding routing plan shall be provided
- b) That the alternate route shall be properly maintained for public safety until such duration that the subject road will be opened back to the public;
- c) That the provisions of international roads signs be it informative and regulatory shall be strictly followed including installation thereto;
- d) That the various roads as parking space subject for temporary closure shall be disseminated to the public stating the specific day and time;
- e) The Engineering Office in coordination of Bayambang Public Safety Office (BPSO) shall provide appropriate and adequate direction information signages, standard warning signs and placed at strategic places in order to notify the riding public of the need to avoid the said roads and/or streets;
- f) That the residents of the area covered by the closure of road shall be given access;
- g) There shall be PNP personnel and BPSO traffic enforcers during the duration of the closure to man the above-described area at all times for direction, safety and security, and rerouting of all passing vehicles;
- h) That in cases of emergency the BPSO shall provide specific route to allow the free flow of traffic to the responder or for an ambulance/rescue vehicle in responding said incident;

SECTION 3. IMPLEMENTATION. To properly regulate and take into account the health, safety and protection, and the convenience of those who may be affected, the Philippine National Police (PNP), and the Bayambang Public Safety Office (BPSO) shall be jointly implemented this Ordinance.

SECTION 4. INFORMATION DISSEMINATION. Immediately upon the approval of this Ordinance, the Public Information Office (PIO) shall conduct an information drive through print and broadcast media, informing the general public of the temporary closure ordinance.

SECTION 5. REPEALING. Any Municipal Ordinance, Municipal Executive Orders, Regulations or parts thereof which are inconsistent with any of the provisions of this Ordinance are hereby repealed or amended accordingly.

SECTION 6. **SEPARABILITY**. If, for any reason or reasons, this Ordinance or any part thereof is declared invalid or unconstitutional, any part or provisions thereof not affected thereby shall continue to be in force and effect.

SECTION 7. **EFFECTIVITY**. This ordinance shall take effect immediately upon its approval.
