MUNICIPAL ORDINANCE NO. 03

“CREATING THE RURAL HEALTH OFFICE V AND VI (RHU V & VI), UNDER THE OFFICE OF THE MUNICIPAL MAYOR OF THE MUNICIPAL GOVERNMENT OF BAYAMBANG, DEFINING ITS FUNCTIONS THEREFORE”

WHEREAS, among the basic services and facilities which the municipalities are mandated to provide pursuant to Section 17 of Local Government Code (RA 7160) are infrastructure facilities intended primarily to service the needs of the residents of the municipality and which are funded out of municipal funds such as clinics, health centers and other health facilities necessary to carry out health services;

WHEREAS, a municipality with more than twenty-five thousand inhabitants shall have an additional rural health units;

WHEREAS, the municipal government of Bayambang needs to address the health concerns and issues of its growing population, thus necessitating the creation of additional Rural Health Units;

WHEREAS, Section 76 of RA 7160 (Local Government Code of 1991) provides every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission”;

NOW THEREFORE, on motion of SB Member Levinson Nessus M. Uy, duly seconded;

BE IT ENACTED, by the Sangguniang Bayan of Bayambang in session assembled that:

Section 1. TITLE. – This Ordinance shall be known as the “*Ordinance Creating Rural Health Unit V and VI of the Municipality of Bayambang, Province of Pangasinan*”.

Section 2. CREATION. There is hereby created the Rural Health Unit V and VI under of the Office of the Municipal Mayor of the Municipal Government of Bayambang. The creation of positions, under Rural Health Unit V and VI shall be created if the Municipality of Bayambang is within the personnel services cap under Section 325 (a) of RA 7160 and funding requirements will be duly appropriated for such purpose.

The functions of Rural Health Unit V and VI will be temporarily handled by Rural Health Unit II and III.



Section 3. SCOPE OF SERVICES – As primary care system, the Rural Health Unit V and VI shall be the main implementor of various health programs, but not limited to, tuberculosis control program (Directly observed treatment, Short-course), Maternal Care Package (MCP), Primary Care Benefit Package (PCB) and Animal Bite Treatment Center (ABTC).

Section 4. SEPARABILITY CLAUSE – It is the Sanggunian's intent if any section, subsection, clause or provision of this ordinance is deemed invalid or unconstitutional by a court of competent jurisdiction, such portion will become a separate provision and will not affect the remaining provisions of this ordinance. The Sanggunian further declares its intent that these provisions of this ordinance would have been adopted if unconditional provision was not included.

Section 5. REPEALING CLAUSE – All local ordinances, resolutions, orders, rules and regulations that are inconsistent with this Ordinance are hereby repealed, modified or amended accordingly.

Section 6. EFFECTIVITY CLAUSE - This Ordinance shall take effect upon its approval.
