AMENDMENT TO EXECUTIVE ORDER NO. 35 SERIES OF 2022 ENTITLED: RECOMPOSITION OF MUNICIPAL NUTRITION COUNCIL OF THE MUNICIPALITY OF BAYAMBANG, PANGASINAN

WHEREAS, Executive Order No. 35 series 2022 "Recomposition of the Municipal Nutrition Council of the Municipality of Bayambang was issued on August 03, 2022 to revitalize the Council and ensure continues coordinated and integrated action in addressing the malnutrition problem in the municipality;

WHEREAS, malnutrition is caused by several factors that cut across various sectors and continued prevalence of malnutrition is unacceptable since it compromises the growth and development not only of individuals, but also of our community;

WHEREAS, there is the need to amend Executive Order No. 35 series 2022 and put in new members to the committee to guarantee a continued effective and efficient sectoral action, shared decision making, and responsibility to address matters related to nutrition improvement;

NOW THEREFORE I, HON. MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO, Municipal Mayor of Bayambang, Pangasinan, by virtue of power vested in me by law, do hereby amend Executive Order No. 35 series 2022, and reconstitute the Municipal Nutrition Committee of Municipality of Bayambang, as follow:

SECTION 2. FUNCTIONS. The Municipal Nutrition Committee shall have the following functions:

- 1. Formulate and implement local food and nutrition policies, plans and interventions for nutrition improvement;
- 2. Monitor and evaluate the efficiency and effectiveness of the plan for nutrition improvement;
- 3. Identify and mobilize local resources for nutrition interventions; and
- 4. Advocate for local support for the nutrition plan to sustain nutrition improvement.

SECTION 3. MEETING. The Municipal Nutrition Committee shall meet every quarter on a day and time agreed upon by the members.

SECTION 4. SEPARABILITY CLAUSE. If any provision of the Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

SECTION 5. EFFECTIVITY. This Executive Order shall take effect immediately and will continue until amended or revoked.
