EXECUTIVE ORDER 002-2016

AUTHORIZING THE MUNICIPAL ADMINISTRATOR, ATTY. RODELYNN RAJINI A. SAGARINO, TO SIGN VOUCHERS AMOUNTING TO P15,000.00 AND BELOW

WHEREAS, Section 444 of R.A. 7160, otherwise known as the Local Government Code of 1991, provides, to wit:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation. -

(a) The municipal mayor, as the chief executive of the municipal government, shall exercise such powers and performs such duties and functions as provided by this Code and other laws.

WHEREAS, the same Section of the Code further provides, to wit:

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

(2) Enforce all laws and ordinances relative to the governance of the municipality and the exercise of its corporate powers provided for under Section 22 of this Code implement all approved policies, programs, projects, services and activities of the municipality and, in addition to the foregoing, shall:

(iii) Issue such executive orders as are necessary for the proper enforcement and execution of laws and ordinances;

WHEREAS, consistent with the power and duties of Local Chief Executives, and in order to provide a more efficient and economical governance that is more responsive to the demands of good governance and public administration, the Municipal Administrator is authorized to sign vouchers amounting to P15,000.00 and below;

AMENDMENT TO EXECUTIVE ORDER 002 - 2016

AMENDING THE AUTHORITY OF THE MUNICIPAL ADMINISTRATOR, ATTY. RODELYNN RAJINI A. SAGARINO, TO SIGN VOUCHERS BY INCREASING THE PREVIOUSLY STATED AMOUNT OF P15,000.00 AND BELOW, TO THE AMOUNT P100,000.00 AND BELOW

WHEREAS, the Office of the Mayor released Executive Order No. 002-2016 dated July 1, 2016, authorizing the Municipal Administrator, Atty. Rodelynn Rajini A. Sagarino, to sign vouchers amounting to P15,000.00 and below;

WHEREAS, there is a need to modify the authority bestowed upon the Municipal Administrator in order to achieve a more effective and economical governance;

WHEREAS, consistent with the power and duties of Local Chief Executives, and in order to provide a public administration that is more responsive to the demands of good governance, the Municipal Administrator's authority to sign vouchers is modified by increasing the previously stated amount of P15,000.00 and below, to the amount P100,000.00 and below;

WHEREFORE, by virtue of the powers vested in me by law, I hereby authorize the Municipal Administrator, Atty. Rodelynn Rajini A. Sagarino, to sign vouchers amounting to One Hundred Thousand Pesos (P100,000.00) and below, subject to and in accordance with prevailing rules and regulations.
