EXECUTIVE ORDER NO. 03, s. 2016

ORGANIZING THE PUBLIC ORDER AND SAFETY OFFICE (POSO) AND DEFINING ITS FUNCTIONS

WHEREAS, the Municipality of Bayambang is an economically progressing hub in the Province of Pangasinan;

WHEREAS, the ideal police-population ratio for an effective law enforcement in a given place or municipality is 1:500. However, this ideal ratio has not been achieved in the Municipality of Bayambang considering that Bayambang has a standing population of 135,953 (2016) and its police force numbers only 58 police personnel;

WHEREAS, the considerable deficiency in the number of police personnel manning the Municipality of Bayambang has affected the peace and order situation of the Municipality as well as its economic growth and progress;

WHEREAS, the 1987 Constitution provides that the government shall promote the quality of life of the people; furthermore, under Section 16 of the Local Government Code of 1991, otherwise known as R.A. No. 7160, it specifically provides that Local Government Units are mandated to implement the constitutional mandate for the adoption and implementation of programs and activities that will preserve the comfort and general welfare of their inhabitants;

WHEREAS, the proliferation of colorum businesses or businesses without Mayor's or Business Permit, the unchecked fly-by-night sex workers, the danger that videoke bars or beer houses pose to the community, the unsanitary operation of business establishments, the video kareras which have been poisoning the minds of innocent children, are alarming indications requiring urgent measures from the local government;

WHEREAS, in this era of development, safety, security and public order requires strict implementation of laws, ordinances and regulations in order to achieve sustainable development;

WHEREAS, there is a pressing need to create an office that will augment the law enforcement task of the local Philippine National Police, especially in the enforcement of local ordinances passed and approve by the local Sanggunian Bayan;

NOW THEREFORE, I, CEZAR T. QUIAMBAO, Municipal Mayor of Bayambang, by virtue of the powers vested in me by law and pursuant to the mandate of the enabling law do hereby ordain the following:

RESOLVED as it is hereby RESOLVED to create, as it is hereby created, the **PUBLIC ORDER AND SAFETY OFFICE**, with acronym "**POSO**" under the Office of the Municipal Mayor, with the following defined powers, functions and organizational structure:

SECTION 1. POLICY AND OBJECTIVE:

To consolidate the varied public order and safety ordinances, resolutions, memorandums, programs and activities into one coherent directional policy and to focus one body specifically designed to meet the immediate and long-term needs of the inhabitants on matters of general welfare and community service.

SECTION 2. CREATION:

There is hereby created a body known as Public Order and Safety Office whose operation shall be on twenty-four (24) hours basis.

SECTION 4. FUNCTIONS AND RESPONSIBILITIES

 To inquire, conduct ocular inspection, examine pertinent documents and investigate each and every business establishment in the Municipality to determine if they have all the necessary permits, regulatory or otherwise, and paid all their taxes due the Municipality. That in case of negative results, the establishment, person or entity concerned shall be required to secure and pay the necessary permits and taxes due the Municipality within a specified period of time from the date of visit, otherwise, endorse the same to the Municipal Legal Officer for appropriate legal action;

- To inquire, conduct ocular inspection, examine pertinent documents and investigate each and every Videoke Bars, Beer Houses, Motor Inns, Resto Bars and Entertainment Club to determine if said establishment, personality or entity have complied not only with the necessary permits and taxes, but especially sanitary and health permits and if the same are still effective;
- In coordination and in the company of PNP officers/personnel, conduct "surprise" raid on illegal gambling, such as tupada, bularit, play card games and other forms of illegal gambling and conduct arrest for violators caught in the act of committing an offense;
- 4. In coordination and under the direct supervision of the PNP, conduct undercover and clandestine intelligence operation on illegal drug addiction, pot session, drug operation, manufacture and illegal drug transport, and to report the results thereof to the Chief of Police of the Municipality for appropriate action;
- To enforce and implement local ordinances, to include but not limited to, enforcement of traffic ordinances;
- 6. To augment the security force of the Municipal Mayor, Municipal Vice Mayor, the Municipal Councilors and visiting Government VIPs and Officials, as well as to protect their lives and well-being, especially during established public events, such as fiestas, public celebrations and the like; and
- To conduct an arrest (citizen's arrest) when they have caught anybody actually committing a crime in their presence. They should, however, immediately bring the arrested person to the police station for appropriate investigation and appropriate legal action.

SECTION 5. INFORMATION/ACTION CENTER AND EMERGENCY HOTLINES:

The POSO shall have an information and Action Center. It shall serve as a One-Stop public assistance center and responsible in coordinating and/or referral of complaint/request with concerned departments or agencies.

It shall be the lead department in the implementation or operation of LGU Bayambang's Emergency Hotlines #4357 (or #HELP) and (075) 633 2977.

SECTION 6. COMPOSITE MANPOWER:

The manpower requirement of the POSO shall be composed of personnel occupying plantilla and coterminous positions. In the event that augmentation of staff/personnel is necessary, the Chairman may assign, detail or transfer some employees from other Municipal Government agencies or departments.

The Municipal Mayor may engage the services of contractual employees or consultants when necessary.

SECTION 7. EFFECTIVITY

This ORDER shall take effect immediately upon signing hereof.
