EXECUTIVE ORDER NO. 005 SERIES OF 2016

ORGANIZING AND RECONSTITUTING THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (MDRRMC) OF THE MUNICIPALITY OF BAYAMBANG, PROVINCE OF PANGASINAN.

WHEREAS, Republic Act No. 10121 (R.A. No. 10121) otherwise known as the "Philippine Disaster Risk Reduction and Management Act of 2010", has been finally approved and signed into law by the Former President of the Republic of the Philippines, Gloria Macapagal-Arroyo, on May 27, 2010;

WHEREAS, this Act is primarily aimed to strengthen the Philippine Disaster Risk Reduction and Management System, provide for the National Disaster Risk Reduction and Management Plan and appropriating funds therefore and for other purposes;

WHEREAS, Section 11 of R.A. No. 10121, provides for the organization of respective Local Disaster Risk Reduction And Management Councils (LDRRMCs) in every local government level emphasizing among others that "The existing Municipal Disaster Risk Reduction and Management Councils, and the Barangay Disaster Coordinating Councils shall cease to exist and its powers and functions shall henceforth be assumed by the existing Barangay Development Councils (BDCs) which shall serve as the LDRRMCs in every barangay";

NOW THEREFORE, I, CEZAR T. QUIAMBAO, Municipal Mayor of the Municipality of Bayambang, Province of Pangasinan, and by virtue of the powers vested in me by law do hereby order the following:

Section I. ORGANIZATION AND RECONSTITUTION/COMPOSITION: The MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (MDRRMC) of the Municipality of Bayambang, Province of Pangasinan is hereby organized and reconstituted and shall be composed of the following:

Section II. FUNCTIONS: The MDRRMC shall have the following functions pursuant to Section 4 under rule 5 of R. A. No. 10121 and its implementing rules and regulations:

1. Approve, monitor and evaluate the implementation of the (MDRRMPs) Municipal Disaster Risk Reduction Management Plans and conduct an annual review to ensure that the plan is consistent with the national and other local planning programs;
2. Ensure the integration of disaster risk reduction and climate change adaptation into local development plans, programs and budgets as a strategy in sustainable development and poverty reduction;
3. Recommend the implementation of forced or preemptive evacuation of local residents, if the situation so demands and necessary; and
4. Convene the local council as provided for by this Act and its Implementing rules and regulations.


Section III. Other Salient Provisions: Other salient provisions of this Act such as but not limited to the definition of terms, fund utilization, capacity building/training programs, disaster office establishment, staffing requirements, powers, duties, functions and responsibilities,


meetings and quorum etc. shall be in accordance and consistent with R.A. No. 10121 and its Implementing Rules and Regulations.

Section 4. Effectivity: This Municipal Executive Order shall take effect immediately.

4. Convene the local council as provided for by this Act and its Implementing rules and regulations.


