



APPROPRIATION ORDINANCE NO. 03
Series of 2016

AUTHORIZING THE MUNICIPAL MAYOR TO TRANSFER THE TOTAL AMOUNT OF FOUR MILLION FOUR HUNDRED THOUSAND PESOS (Php4,400,000.00) FROM ACCOUNT NOS. 100-1011-5-02-99-990 (OTHER SERVICES), 100-1011-5-02-03-070 (MEDICINES), 100-1011-5-02-16-030 (INSURANCE), PHILHEALTH OF INDIGENT FAMILIES AND COMMUNITY HEALTH/DEVELOPMENT/PROJECTS TO THE ACCOUNT GENERAL SERVICES, IN ORDER TO AUGMENT THE BALANCE UNDER WAGES OF JOB ORDER EMPLOYEES UNDER THE OFFICE OF THE MUNICIPAL MAYOR-EXECUTIVE SERVICES.

WHEREAS, the amount left under accounts 1011-1011-5-02-99-990 (General Services-Wages of Job Order Employees) is not sufficient to meet the obligations under the said account;

WHEREAS, the total amount of Four Million Four Hundred Thousand Pesos (Php4,400,000.00) from Account Nos. 100-1011-5-02-99-990 (Other Services), 100-1011-5-02-03-070 (Medicines), 100-1011-5-02-16-030 (Insurance), PhilHealth of Indigent Families and Community Health/Development/Projects are available to augment the balance under accounts General Services-Wages of Job Order Employees;

WHEREAS, Section 336 of the Local Government Code provides that the local chief executive or the presiding officer of the sanggunian concerned may, by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations;

WHEREAS, in order to comply with the municipality's obligation to provide wages to its employees who are under Job Order Arrangements, in accordance with prevailing rules and regulations;

WHEREFORE, on motion of **SB Member Junie J. Angeles**, duly seconded;

Be it enacted by the Sangguniang Bayan in session duly assembled that:

SECTION 1. THE SANGGUNIANG BAYAN HEREBY AUTHORIZED THE MUNICIPAL MAYOR TO TRANSFER OF Php4,400,000.00 FROM OTHER SERVICES, MEDICINES, INSURANCE, PHILHEALTH OF INDIGENT FAMILIES AND COMMUNITY HEALTH/DEVELOPMENT/PROJECTS TO GENERAL SERVICES UNDER THE OFFICE OF THE MUNICIPAL MAYOR-EXECUTIVE SERVICES.
