EXECUTIVE ORDER NO. 024 - S 2016

"REORGANIZING THE LOCAL POVERTY REDUCTION ACTION TEAM (LPRAT)"

WHEREAS, DBM-DILG-DSWD-NAPC Joint Memorandum Circular (JMC) No. 05, Series of 2014 provides for Policy Guidelines and Procedures in the Implementation of Grassroots Participatory Budgeting (GPB) for the FY2016 Budget Preparation;

WHEREAS, under Paragraph 6.3.2 of said JMC, the Local Chief Executive (LCE) shall constitute or reconstitute the Local Poverty Reduction Action Team (LPRAT) based on the members as identified in Section 4.9 and based on the process undertaken pursuant to Section 6.2. The LCE must ensure the active participation of the elected Civil Society Organization (CSO) representatives in the LPRAT during the Local Poverty Reduction Action Plan (LPRAP) workshop and ensure the conduct of regular meeting and mobilization of the LPRAT to comply with the requirements of the DILG's Seal of Good Local Governance and implement a Public Financial Management (PFM) Improvement Plan;

WHEREAS, consonant to the mandate of the aforesaid laws and issuance, a Local Poverty Reduction Action Team shall reorganize and spearhead the formulation and monitoring of the Local Poverty Reduction Action Plan (LPRAP).

NOW THEREFORE, I, CEZAR T. QUIAMBAO, Municipal Mayor, by virtue of the powers vested upon me by law, hereby reorganize the LOCAL POVERTY REDUCTION ACTION TEAM (LPRAT) OF BAYAMBANG, PANGASINAN which shall be composed of the following:

A. Organize and facilitate the conduct of a Local Poverty Reduction Planning (LPRAP) Workshop for the formulation of the LPRAP and the identification of priority poverty reduction project;


B. Agree on a list of priority poverty reduction project for 2016 based on the LPRAP and submit it to the RPRAT using the template provided for under DBM-DILG-DSWD-NAPC Joint Memorandum Circular No. 05, S. 2014

C. Conduct quarterly meetings to monitor the status of the approval and integration of the priority poverty reduction project in to the budgets of participating agencies and monitor the implementation and status of the projects; and

D. Perform all acts which necessary or desirable in order to carry out to its fullest the foregoing functions.

This Executive Order shall take effect immediately.
