EXECUTIVE ORDER NO. 032 Series of 2016

DESIGNATING A FOCAL PERSON ON SOLID WASTE MANAGEMENT IN THE MUNICIPALITY OF BAYAMBANG, PANGASINAN

WHEREAS, Section 12 under Article 1 of Republic Act No. 9003 provides for the creation of Municipal Solid Waste Management Board that shall prepare, submit and implement plan for the safe and sanitary management of solid waste generated in areas its geographic and political coverage;

WHEREAS, the increasing volume of garbage is posing a serious threat to the general welfare and health of the people, as well as to the integrity of the environment;

WHEREAS, this health and environment problem requires utmost attention and cooperation among the concerned national government agencies, local government units, business community, civil society and the people in general;

NOW, THEREFORE I, CEZAR T. QUIAMBAO, Municipal Mayor of the Municipality of Bayambang, Pangasinan, by virtue of the powers vested in me by law, do hereby designate MR. ROGELIO DELA DV. PEÑA as Focal Person on Solid Waste Management of the Municipality of Bayambang, Pangasinan.

MR. ROGELIO DV. DELA PEÑA shall perform the following functions:

- 1. Oversee and monitor the implementation of the Municipal Solid Waste Management Plan.
- Conduct orientation with various sector of the community on the effective implementation of the Solid Waste Management Plan.
- 3. Provide the necessary logistical and operational support to its components barangays in consonance with subsection (f) of Section 17 of Local Government Code;
