“ESTABLISHMENT OF PEACE AND ORDER COUNCIL TECHNICAL WORKING GROUP (POC TWG)”

WHEREAS, Pursuant to Section 116 of Republic Act No. 7160, or the “Local Government Code of 1991”, and Executive Order No. 773, Series 2009, which calls for the further reorganization of the Peace and Order Council every municipality is mandated to create a Peace and Order Council;

WHEREAS, Memorandum Circular 2015-130 Section A (2) (k) provides that local government units shall create a Technical Working Group (TWG) for the purpose of Peace and Order and Public Safety (POPS) Planning, following the guidelines prescribed by the DILG on the tools and processes on POPS Planning;

- A. Prepare documents that can serve as reference for the profiling of the strategic direction and peace and order and public safety issues in the locality such as the Local Government Units (LGUs) Comprehensive Development Plan.
- B. Conduct data gathering and stakeholder consultations, as needed, and initially analyze data gathered.

- C. Coordinate with communities/ barangays for data-gathering and action planning for implementation of POPS Plan.
- D. Present data to the Peace and Order Council (POC) for prioritization of issues and development of strategies.
- E. Participate in the POPS Planning process and draft parts of the POPS Plan as assigned and/or participate in the writeshop to finalize the POPS Plan.
- F. In coordination with the Mayor, convene the POC and present the Plan for discussion, approval and appropriate action.
- G. Deliver the submission and adoption of the POPS Plan.
- H. Coordinate/ engage with internal and external stakeholders for effective communication and monitoring as laid out in the POPS Plan.
- I. Ensure inclusion of key programs or strategies (Memorandum Circular 2015-128, Annex 3) such as Community and Service-Oriented Policing (CSOP) and conflict- sensitivity, as appropriate, in the POPS Plan and process.
- J. Regularly submit Accomplishment Reports and coordinate adjustments to the POPS Plan as needed based on findings from Accomplishment Reports.

SECTION 3. EFFECTIVITY

This Executive Order shall take effect immediately.
