### REORGANIZING/RECONSTITUING THE SMALL AND MEDIUM ENTERPRISE DEVELOPMENT COUNCIL OF THE MUNICIPALITY OF BAYAMBANG, PANGASINAN

## **MUNICIPAL MAYOR OF BAYAMBANG**

#### Section 2. Duties and Responsibilities.

- A. Help establish the needed environment and opportunities conducive to the growth and development of enterprises in the locality;
- B. Recommend to the Sanggunian all policy matters affecting businesses in the locality;
- C. Formulate a local entrepreneurship development plan (LEDP) to be integrated into the Local Development Plan and facilitate implementation of the same;
- D. Coordinate and integrate various government and private sector activities in the locality relating to enterprise development;
- E. Formulate, disseminate and advocate policies, principles and implementing guidelines in the development and promotion of local enterprises; and
- F. Develop and provide appropriate services beneficial to local enterprises and entrepreneur.

#### Section 3. Effectivity.

This Executive Order shall take effect immediately.
