EXECUTIVE ORDER NO. 36

"AN ORDER ORGANIZING THE EXPANDED UBAS (UGNAYAN NG BARANGAY AT SIMBAHAN) TECHNICAL WORKING GROUP (TWG) AND COMMUNITY REHABILITATION NETWORK (CRN) OF THE MUNICIPALITY OF BAYAMBANG, PANGASINAN IN SUPPORT TO THE MASA MASID (Mamamayan Ayaw Sa Anomalya, Mamamayan Ayaw Sa Ilegal na Droga) PROGRAM OF THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG)"

WHEREAS, Republic Act 9165 known as the "Comprehensive Dangerous Drugs Act of 2002" protects the state and its individuals from the possible harms brought about by the abuse of illegal drug substances. It also has provisions supporting the unrelenting campaign against trafficking and use of illegal drugs through and effective enforcement of anti-drug policies, programs and projects;

WHEREAS, Local Government Code of 1991 also has provisions that encourages multi-sectoral participation. In section 3 (1), it is stated that "the participation of the private sector in local governance, particularly in the delivery of basic services, shall be encouraged to ensure the viability of local autonomy as an alternative strategy for sustainable development", and in section 35, which states that "local government units may enter into joint ventures and such other cooperative arrangements with people's and non-governmental organizations to engage in the delivery of certain basic services, capability building..."

WHEREAS, given the above mentioned legal provisions, the Department has enough bases to support the President's pronouncement to suppress criminality and corruption, by creating an 'umbrella organization' to consolidate the efforts of all barangay-based institutions against the above mentioned issues, through active people's participation, the spirit of volunteerism will be sparked and will eventually be institutionalized;

WHEREAS, the MASA MASID is a community-based initiative to engage volunteers in the fight against criminality, corruption and illegal drugs through the adoption of a multi-sectoral and mass-based approach;

WHEREAS, MASA MASID is designed to enhance the conduct of advocacy and education campaigns and information gathering and reporting to reduce the supply and demand of illegal drugs, and community-based rehabilitation program to address the need for interventions of the surrendering drug personalities in the country;

NOW THEREFORE, I, CEZAR T. QUIAMBAO, Municipal Mayor of the Municipality of Bayambang, Pangasinan, for and in consideration of the foregoing premises, by virtue of the power vested upon me by law, do hereby order:

SECTION 2. Functions.

The Expanded UBAS Municipal Technical Working Group (TWG) will serve as the social facilitator of the MASA MASID Program. The Team will be responsible in convening, organizing, training and mobilizing the MASA MASID Team at the barangay level.

1. DILG Municipal Field Offices, as chair
 - Spearhead the organization and mobilization of the Expanded UBAS C/M TWG and MMT;
 - Conduct orientation/training of the MMTs;
 - Maintain a registry of the MMTs; and
 - Oversee the implementation of the MASA MASID Program within their jurisdiction, and ensure its successful implementation.
2. The Local PNP as member
 - Assist in the organization and in capacitating the MASA MASID Teams;
 - Provide technical assistance; and
 - Assess the reports submitted by the MMTs, and take necessary actions including, but not limited to, filing of cases and/or referral of drug users for counselling and/or rehabilitation, depending on the frequency of the use of illegal drugs.
3. The Liga ng mga Barangay as member
 - Assist in the organization and orientation of the MASA MASID Team;
 - Collaborate with the MMTs in the implementation of MASA MASID;
 - Assist in coordinating with partner organizations for the provision of aftercare and livelihood program for the RDDs;
 - Conduct advocacy and information campaigns against illegal drugs within their jurisdiction.

4. The members of the Faith-Based and Inter-Faith Organizations as member
 - Assist in organizing and orienting the MMTs;
 - Mobilize the support of faith based organizations;
 - Spearhead the advocacy and education campaigns in the community;
 - Assist in the implementation of Community-Based Rehabilitation Program; and
 - Assist in the implementation of community-Based reintegration of the Recovering Drug Dependents back to the communities.
5. The Municipal Anti-Drug Abuse Council Representative
 - Work closely with the DILG Municipal Field Office on the implementation of MASA MASID Program;
 - Provide technical and administrative support; and
 - Act as secretariat.
