REORGANIZATION OF MUNICIPAL COMMITTEE ON ANTI-TRAFFICKING AND VIOLENCE AGAINST WOMEN AND THEIR CHILDREN (MCAT-VAWC) AND DEFINING ITS FUNCTIONS

WHEREAS, Republic Act No. 9208, otherwise known as the Anti-Trafficking in Persons Act of 2003, and Republic Act No. 9262, or the Anti-Violence Against Women and their Children Act of 2004, are the two (2) national laws which provide stronger mandates and direction towards addressing human trafficking and violence against women and their children.

WHEREAS, Joint Memorandum Circular 2010-01 of the Department of the Interior and Local Government (DILG), the Department of Social Welfare and Development (DSWD) and the Department of Justice (DOJ) dated October 18, 2010 provides the creation of the Local Committees on Anti-Trafficking and Violence Against Women and their Children in provincial, city and municipal level;

NOW, THEREFORE, I, CEZAR T. QUIAMBAO, Municipal Mayor of the Municipality of Bayambang, Pangasinan, by virtue of the powers vested in me by law, do hereby create the Municipal Committee on Anti-Trafficking and Violence Against Women and their Children (MACT-VAWC) of this municipality.

4. Monitor and oversee the strict implementation of RA 9262 and other related laws for the protection of women and children and of the Inter Agency Council Against Trafficking (IACAT) and Inter Agency Council Violence Against Women and Children (IACVAWAC) national plan of action.
5. Implement the programs and activities as stated in the national plan of action.

SECTION 3. SECRETARIAT: The Municipal Social Welfare and Development Office shall serve as the secretariat of this committee.

SECTION 4. FUNDING REQUIREMENTS: The Municipal government through the SB shall allocate funds from Gender and Development and other sources for the operation and implementation of programs, projects and activities of the committee.

SECTION 5. EFFECTIVITY: This Executive Order shall take effect immediately.
