## EXECUTIVE ORDER NO. 043 SERIES OF 2016

### REORGANIZATION/RECONSTITUTION OF LOCAL COUNCIL FOR THE PROTECTION OF CHILDREN (LCPC)

**WHEREAS**, pursuant to Department of the Interior and Local Government (DILG) Memorandum Circular No. 2002-121 dated August 5, 2002, Local Government Units are encouraged to organize their respective Local Council for the Protection of Children (LCPC) per provisions of Presidential Decree 603 as mandated on Republic Act 8990, which shall be responsible in planning and spearheading programs for children in the locality with the end view of making the locality child-friendly;

**WHEREAS**, Republic Act No. 7160, the Special Protection of Children Against Child Abuse, Exploitation and Discrimination Act provides for stronger deterrence and special protection against child abuse, exploitation and discrimination, and its corresponding penalties;

**NOW THEREFORE, I, CEZAR T. QUIAMBAO**, Municipal Mayor of the Municipality of Bayambang, Province of Pangasinan, and by virtue of the powers vested in me by law, do hereby order and direct the following:

### SECTION 2. FUNCTIONS

The Council has the following functions:

1. Formulate plans, programs and policies for children that are gender-fair, culturally relevant and responsive to the needs of diverse groups of children 0 to below 18 years of age;
2. Prepare Annual Work and Financial Plan (AWFP) for children and recommend appropriations to the Sanggunian;
3. Provide coordinative linkages with other agencies and institutions in the planning, monitoring and evaluation of plans for children;
4. Provide technical assistance and recommend financial support to the Barangay Council for the Protection of Children;
5. Establish and maintain database on children in the municipality;
6. Foster the education of every child;


7. Advocate for the establishment and maintenance of playgrounds, day care centers and other facilities necessary for child and youth development;
8. Recommend local legislations promoting child survival, protection, participation and development, especially on the quality of television shows, media prints and coverage, which are detrimental to children, and with appropriate funding support;
9. Assist children in need of special protection and refer cases filed against child abuser to proper agencies/institutions;
10. Conduct capability building programs to enhance knowledge and skills in handling children's program;
11. Document barangay best practices on children;
12. Monitor and evaluate the implementation of the program and submit quarterly status report Provincial Council for the Protection of Children (PCPC);
13. Perform such other functions as provided for in the Early Childhood Care and Development (ECCD) and other child related law.

**SECTION 3.** The Sangguniang Bayan of Bayambang, Pangasinan shall set aside funds which may be necessary to carry out the specific roles and responsibilities in pursuance of this Order.

**SECTION 4.** Other members may be added to the council from time to time as the need arises.

**SECTION 5.** This order shall take effect immediately.
