2. Participate in policy assessment and formulation, planning of programs and projects to meet the identified needs in agriculture, fishery, agribusiness and related activities;
3. Assist in the preparation of the Municipal Agriculture and Fisheries Plan and submit it to the Municipal Development Council;
4. Implement the approved Municipal Agriculture and Fisheries Plan and assist in the programs and projects of the Department of Agriculture (DA) and its attached agencies;
5. Conduct regular consultations/congresses with Barangay Fishery and Aquatic Councils (BFACs) and other various interested groups to identify opportunities available and to address problem/issues affecting agricultural development in the area;
6. Conduct regular and special meetings to update members on latest issuances, policies, updates and issues concerning agriculture & fishery;
7. Recommend the enactment of municipal agriculture and fisheries ordinances to the Sangguniang Bayan through its Committee on Agriculture and Cooperatives;
8. To source out/raise funds for the implementation of programs, projects and activities of the Council;
9. To promote capability building activities for MAFC officers and BFAC officers and members.

Section 3. Meetings. The Council shall conduct its regular meeting every quarter at a date, time and venue as agreed upon by the members. Special meetings may be called by the Chairman or on his absence by the acting chairman or upon written request of the majority of members. Notices of meetings shall be sent at least one week before the set date. In urgent cases, at least one working day before the meeting.

Section 4. Effectivity. This Executive Order takes effect immediately.
