## EXECUTIVE ORDER NO. 050 SERIES OF 2016

### DESIGNATION OF THE LOCAL ECONOMIC AND INVESTMENT PROMOTION OFFICER

**WHEREAS**, the Local Government should play an active role in attracting more investment by providing an enabling environment that will generate and enhance economic activities;

**WHEREAS**, Department of Interior Local Government (DILG) Memorandum Circular No. 2010-0113, dated October 13, 2010, provides for the designation of Local Economic and Investment Officer;

**NOW THEREFORE, I, CEZAR T. QUIAMBAO**, Municipal Mayor of Bayambang, Pangasinan, by virtue of the powers vested in me by law, do hereby designate **MR. LEVIN N. UY**, as the Local Economic and Investment Officer.

#### Section 1. Functions

1. Facilitate the preparation, coordination and execution of local economic and investment promotion policies, projects and activities of the municipality;
2. Facilitate the establishment of aggressive, systematic, coordinated, sustained promotion and marketing of the Local Government Unit (LGU) as investment location;
3. Provides basic information about business potentials of the LGU including LGU services to prospective investors to attract more investments to flow in the community;
4. Establish a local economic data base containing relevant facts and figures;
5. Coordinate with other offices in the promotion of economic activities such as the Planning and Development Office, Treasury, Budget Office and the Local Sanggunian; and
6. Conduct information dissemination on local government policies.


