AN EXECUTIVE ORDER ORGANIZING THE PLANNING TEAM OF BAYAMBANG, PANGASINAN

WHEREAS, pursuant to Sections 109 (1) and 112 of the Local Government Code 1991, Local Government Units (LGU's) should organize a planning team as a functional committee that shall assist the Local Development Council in the performance of its functions which include the formulation of development plans and policies;

WHEREAS, the planning team should ensure that climate change and disaster risk are considered in the formulation of the local development plans;

WHEREAS, the planning team are highly encouraged to tap the national government agencies and academe as technical and/or scientific advisors and sources of information.

NOW, THEREFORE, I, CEZAR T. QUIAMBAO, Municipal Mayor of Bayambang, Pangasinan, by virtue of the powers vested in my by law, do hereby organized the PLANNING TEAM of Bayambang, Pangasinan.

The Planning Core Group shall be the overall committee responsible for coordinating all technical and administrative activities in the preparation of the Comprehensive Land Use Plan (CLUP), Comprehensive Development Plan (CDP) and derivative plans. It shall coordinate planning activities; and draft and consolidate the contents of these plans. The Local Planning and Development Coordinator shall lead this core team.


