### REORGANIZING THE LOCAL GOVERNANCE PERFORMANCE MANAGEMENT – SEAL OF GOOD LOCAL GOVERNANCE (LGPMS-SGLG) TEAM FOR THE MUNICIPALITY OF BAYAMBANG

**WHEREAS**, the Department of the Interior and Local Government (DILG) developed the LGPMS, a web-based system that has the ability to produce information on the state of local governance performance, and the state of local development, using governance and development indicators;

**WHEREAS**, the LGPMS serves as an online national information system on local governments; and is a self-assessment, management and development tool that enable local governments to determine their capabilities and limitations in the delivery of essential public services;

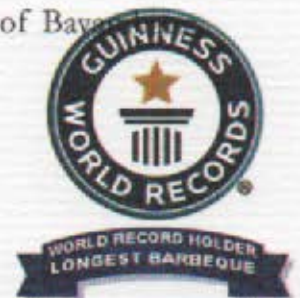
**WHEREAS**, DILG Memorandum Circular 2017-53 re: 2017 Seal of Good Local Governance (SGLG) states that the LGPMS continues to be the operational platform of the SGLG and the designated LGPMS-SGLG Google Drive serves as the main storage facility of all documents and databases relative to Local Government Unit (LGU) Assessments and their supporting documents;

**WHEREAS**, there is a need to reorganize the Local Government Unit-Local Governance Performance Management (LGU-LGPMS) Team in order to ensure that its membership and functions are kept updated to conform to the requirements of the up scaled SGLG;
