EXECUTIVE ORDER NO. 016

CREATION OF TASK FORCE MANGABUL

WHEREAS, the so called Mangabul Reservation located in San Gabriel 2nd, Bayambang, Pangasinan, has been designated by the Bureau of Lands Survey as Insular Public Domain (IPD-92), by virtue of Act No. 4041 of 1933;

WHEREAS, said Reservation as public domain used to be partly forested and partly lake, with an area of approximately 2,059 hectares;

WHEREAS, that same Act No. 4041 of 1933 awarded a usufructuary rights to the Municipality of Bayambang over the fishery area commonly referred to as the Mangabul Fishery Reservation;

WHEREAS, through a period of time, the forested portions of the Mangabul Reservation were converted into agricultural production, and the constant accumulation of silt, and eventually the lahar flow from Mt. Pinatubo, has decreased the fishery area into little more than a few shallow creeks during the dry season;

WHEREAS, at present the whole area of Mangabul Reservation has practically become farmlands and the site of residential houses comprising of eight (8) barangays;

WHEREAS, controversies eventually arose between the farmers and the occupants, on one hand, and the Municipality of Bayambang and the lessees of the fishery reservation, on the other hand, as claimants;

WHEREAS, the Local Government Unit of Bayambang under the present Administration, with due respect to higher authorities, is strongly interested to put an end to legal issues and agrarian unrest in the area, and to promote peace and security, and greater productivity within the community, in particular, and the municipality in general, and consistent with exciting laws and requirements of environmental conservation;



Section 2. Duties and Functions

- 2.1 To determine the status of the present Mangabul Reservation in terms of its dual land use, those of a fishery and agricultural production.
- 2.2 To identify the workers, farmers, lessees, and actual occupants of the area.
- 2.3 To look into the feasibility of classifying Mangabul Reservation into alienable and disposable land of public domain for the purpose of redistributing the same to bonafide and long term farmers/occupants.
- 2.4 To coordinate with other concerned government agencies and accredited organizations in resolving obtaining issues and problems in the area.

Section 3. Effectivity. This Executive Order shall take effect immediately.
