EXECUTIVE ORDER NO. 017 Series of 2017

ESTABLISHING A SMOKE-FREE BAYAMBANG AND ESTABLISHING A SMOKE-FREE BAYAMBANG TASK FORCE

WHEREAS, the President of the Philippines, Rodrigo R. Duterte, signed Executive Order No. 26 on May 16, 2017 "Providing for the Establishment of Smoke-Free Environments in Public and Enclosed Places;"

WHEREAS, E.O. No. 26 prohibits, among other things, "smoking in certain public places" (except in designated smoking areas or DSAs) and the "purchase and sale of cigarettes and other tobacco products to and by minors and in certain places frequented by minors and provides penalties for any violation of the prohibitions;"

WHEREAS, E.O. No. 26 sets the standards for DSAs in Section 4 and the penalties to be imposed in case of violations of the Order in Section 7 thereof;

WHEREAS, the Local Government Unit of Bayambang directs all of its constituents, particularly all Punong Barangays, to strictly follow F. O. No. 26's provisions;

WHEREAS, the LGU hereby creates a Smoke-Free Task Force to carry out the provisions of E.O. No. 26, i.e., to see to it that the smoking prohibitions are strictly observed; any violation will be meted out with penalties as stated in the Executive Order;

NOW, THEREFORE, I, CEZAR T. QUIAMBAO, by virtue of the powers vested in me by law as Local Chief Executive of the Municipality of Bayambang, do hereby declare **BAYAMBANG** as a **SMOKE FREE MUNICIPALITY** and the creation of **SMOKE FREE BAYAMBANG** Task Force, with the following stipulations:

Section 1. The composition of the Smoke-Free Bayambang Task Force is as follows:

Section 2. Duties and Functions

- 2.1 To implement the pertinent provisions of Executive Order No. 26 issued by President Rodrigo Roa Duterte.
- 2.2 To identify, designate and restrict the non-smoking areas and smoking areas in the municipality.
- 2.3 To impose fines and penalties upon, and to cause the prosecution, when necessary, all violators of the EO.
- 2.4 To formulate and enforce plans, policies and regulations for the strict compliance and implementation of the EO.

Section 3. Effectivity. This Executive Order shall take effect immediately.
