ORGANIZING THE MUNICIPAL THERAPEUTIC COMMITTEE

WHEREAS, there is a need to ensure that patients are provided with the best possible cost-effective and quality of care through determining what medicines will be available, at what cost, and how they will be used;

WHEREAS, in order to improve our Medical Drugs and Supply Management, a Therapeutic Committee is hereby ordered organized;

WHEREAS, the committee shall be responsible for determining the list of proper drugs and supplies to be purchased, needed to carry out our mandate of providing quality medical services to constituents; and

WHEREAS, implementation of proper storage and distribution of such drugs and supplies is needed;

NOW THEREFORE, I, CEZAR T. QUIAMBAO, Municipal Mayor of Bayambang, Pangasinan, by virtue of the powers vested in me by law, do hereby organize the Municipal Therapeutic Committee of this municipality, as follows:

1. Advisory committee to medical staff, administration and pharmacy.
2. Development of drug policies.
3. Evaluating and selecting medicines for the formulary list.
4. Developing standard treatment guidelines.
5. Assessing medicine use to identify problems.
6. Conducting effective interventions to improve medicine use.
7. Managing adverse drug reactions.
8. Managing medication errors.
9. Information dissemination.


