“ESTABLISHING/CONSTITUTING THE PRIVATE-PUBLIC PARTNERSHIP (PPP) SUB-COMMITTEE IN THE MUNICIPAL DEVELOPMENT COUNCIL (MDC) OF THE MUNICIPALITY OF BAYAMBANG, PROVINCE OF PANGASINAN”

WHEREAS, Section 20 Article 5 of the Philippine Constitution and likewise, Section 1 of Republic Act 7718 otherwise known as the Build Operate Transfer (BOT) Law as amended, recognizes the role of the private sector as the main engine for national growth and development, and provides the most appropriate incentives to mobilize private resources for the purpose of financing infrastructure and development projects implemented by the government.

WHEREAS, Department of the Interior and Local Government Memorandum Circular No. 2011-16, enjoins all Local Government Units (LGUs) to create and establish a Public-Private Partnership (PPP) Sub-Committee in the Local Development Councils to assist the LGUs in setting economic and social development, and coordinate the development efforts as provided in Section 106 of the Local Government Code of 1991;

NOW THEREFORE, I CEZAR T. QUIAMBAO, Municipal Mayor of the Municipality of Bayambang, Province of Pangasinan, by virtue of the powers vested in me by law, do hereby organize the Public Private Partnership (PPP) Sub-Committee in the Municipal Development Council of the Municipality of Bayambang, Pangasinan as follows:


Section 2. Duties and Functions.

- A. The PPP Sub-Committee shall assist the LGU through the Local Development Council (LDC) in setting the economic and social development, and coordinate the development efforts as provided for in Section 106 of the Local Government Code of 1991;
- B. The Sub-Committee shall, among others, assist the LDC in the formulation of action plans and strategies related to the implementation of PPP programs and projects per Executive Order No. 08 Series of 2010.

Section 3. Effectivity.

This Executive Order shall take effect immediately.
