CREATING A TASK FORCE TO MONITOR AND TO RESTRICT STUDENTS FROM LOITERING AROUND DOWNTOWN AREA DURING SCHOOL HOURS

WHEREAS, the Municipality of Bayambang upholds education as among the pillars of a town committed to its mission and vision;

WHEREAS, the Municipality of Bayambang equally advocates the protection of its youth and their interests as well as the promotion of their welfare;

WHEREAS, the Local Government Unit of Bayambang has been a recipient of complaint from Bayambang National High School, through its Supreme Student Government regarding the loitering of some of its students around the premises of the Royal Mall, Magic Mall, CSI Bayambang, the dike area along the Agno River, the Municipal Plaza, and several computer shops near the school even during class hours;

WHEREAS, these activities are contrary to the aforementioned ideals being upheld by the Municipality and shared by Bayambang National High School and all other local elementary and secondary high schools, as these activities promote truancy, juvenile delinquency and possibly even more harmful habits among our school-age youth such as drugs and premature sexual activity;

NOW, THEREFORE, I, CEZAR T. QUIAMBAO, by virtue of the powers vested in me by law as Local Chief Executive of the Municipality of Bayambang, do, hereby, declare the creation of **MONITORING Task Force**, with the following stipulations:

Section 2. Duties and Functions

2.1 To monitor students around the premises of the Royal Mall, Magic Mall, CSI Bayambang, the dike area along the Agno River, the Municipal Plaza, and several computer shops near the school during class hours.

2.2 To restrict students from loitering in the Downtown Area during class hours.

2.3 To apprehend and refer the students loitering around the Downtown Area during class hours to their respective schools for appropriate action.
