## EXECUTIVE ORDER NO. 028-2017

### AUTHORIZING THE TRANSFER OF FUNDS IN THE GENERAL FUND

**WHEREAS**, the amounts left under accounts GENERAL SERVICES (WAGES OF JOB ORDER EMPLOYEES) and CONSULTANCY SERVICES are not sufficient to meet the obligations under the said accounts;

**WHEREAS**, the total amount of TWO MILLION FOUR HUNDRED THOUSAND PESOS (P 2,400,000.00) from accounts SCHOLARSHIP PROGRAM, HRMO'S CAPABILITY BUILDING, HMRO'S OTHER SERVICES AND MUNICIPAL ASSESSOR'S EXTRA ORDINARY EXPENSES are available to augment the balance under accounts GENERAL SERVICES (WAGES OF JOB ORDER EMPLOYEES) AND CONSULTANCY SERVICES OF THE MUNICIPAL MAYOR.

**WHEREAS**, in order to expedite the delivery of basic services of the municipality and to avoid the loss of vital personnel in the municipality, there is a necessity to transfer the following available funds in the General Fund:

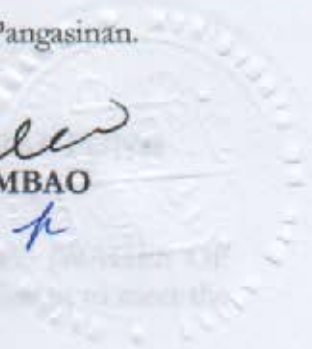
