

THE BAC SHALL BE PRIMARILY RESPONSIBLE FOR THE POSTING OF ADVERTISEMENTS AND/OR INVITATIONS TO BID, PREPARATION OF PRE-PROCUREMENT AND PRE-BID CONFERENCES, DETERMINATION OF THE ELIGIBILITY OF PROSPECTIVE BIDDERS, RECOMMEND AWARD OF CONTRACT TO THE LOCAL CHIEF EXECUTIVE OF THE MUNICIPALITY.

ALL PROCEEDINGS OF THE BAC SHALL BE DONE IN ACCORDANCE WITH THE REQUIREMENTS SET FORTH IN REPUBLIC ACT NO. 9184 AND ITS IMPLEMENTING RULES AND REGULATIONS.

ALL ORDERS, RULES AND REGULATIONS, ISSUANCES OR ANY PART OF COMING FROM THIS OFFICE THAT IS INCONSISTENT WITH THIS ORDER ARE HEREBY REPEALED, AMENDED OR MODIFIED ACCORDINGLY.
