AMENDMENT OF REORGANIZATION/RECONSTITUTION OF THE MICRO, SMALL AND MEDIUM ENTERPRISE DEVELOPMENT COUNCIL (MSMEDC) OF THE MUNICIPALITY OF BAYAMBANG, PROVINCE OF PANGASINAN

- F. Develop and provide appropriate services beneficial to local enterprises and entrepreneur.

Section 3. Effectivity.

This Executive Order shall take effect immediately.

All orders, rules and regulations, issuances or any part of coming from this office that is inconsistent with this order are hereby repealed, amended or modified accordingly.
