## EXECUTIVE ORDER NO. 001 SERIES OF 2018

### AN ORDER CREATING THE BARANGAY SEAL OF GOOD LOCAL GOVERNANCE MUNICIPAL ASSESSMENT TEAM (BSGLG MAT)

**WHEREAS**, the Department of the Interior and Local Government (DILG) developed the Barangay Seal of Good Local Governance (BSGLG), a mechanism which seeks to determine and establish the level of performance of the barangay government across several areas such as Administration, Social Services, Economic Development, and Environmental Management (ASEE) in relation to the mandates of the 1991 Local Government Code and other related laws;

**WHEREAS**, the leverage of this project serves as guide for the higher local government units, the national government and other service providers to determine the kind of policy and program intervention the barangay needs.

**WHEREAS**, as our barangay officials are doing their part to promote better governance, we adopted a mechanism to keep track of the barangay's productivity, the Barangay Seal of Good Local Governance Data Capture Form (BSGLG DCF). Hence the creation of a BSGLG Municipal Assessment Team.

**NOW, THEREFORE, I, CEZAR T. QUIAMBAO**, Municipal Mayor of Bayambang, by virtue of the power vested in me by law, do hereby order the creation of Barangay Seal Of Good Local Governance Municipal Assessment Team (BSGLG MAT) as follows:
