### AMENDMENT TO EXECUTIVE ORDER NO. 008, SERIES OF 2018: REORGANIZING THE MUNICIPAL ADVISORY COMMITTEE (MAC) FOR THE PANTAWID PAMILYANG PILIPINO PROGRAM
