### CREATION AND COMPOSITION OF THE MUNICIPAL EXECUTIVE COMMITTEE

**WHEREAS**, a Municipal Executive Committee shall be the authorized body to provide advice and support to the Local Chief Executive in decision-making and other necessary assistance needed thereof

**NOW, THEREFORE, I, CEZAR T. QUIAMBAO**, Municipal Mayor of the Municipality of Bayambang, Province of Pangasinan, by virtue of the powers vested in me by law, do hereby create the Municipal Executive Committee of the Municipality of Bayambang, with the following:

**Section 1. CREATION:** There shall be created a Municipal Executive Committee tasked to develop, coordinate and see to the implementation of all plans and programs of the Municipality.
