## EXECUTIVE ORDER NO. 019 SERIES OF 2018

### AMENDING EXECUTIVE ORDER NO. 41 – SERIES OF 2016 REORGANIZING/RECONSTITUTING THE MUNICIPAL TOURISM COUNCIL OF THE MUNICIPALITY OF BAYAMBANG

**WHEREAS**, Department of the Interior Local Government (DILG) Memorandum Circular No. 95-162 dated 2, October 1995, provides for the organization of the local tourism councils to be composed of government and private sector representatives;

**WHEREAS**, Section 17 of the Local Government Code of 1991 supports local tourism initiatives;

**NOW THEREFORE, I, CEZAR T. QUIAMBAO**, Municipal Mayor of the Municipality of Bayambang, Province of Pangasinan, by virtue of the powers vested in me by law, do hereby reorganize the Municipal Tourism Council of the Municipality of Bayambang, Pangasinan, with the following:

- C. Adopt and promote Department of Tourism (DOT)-accreditation standards for Local Government Units (LGUs) and licensing of tourism establishment;
- D. Assist in the regulation and supervision of tourism-oriented establishments thereby ensuring wholesome and clean tourism activities;
- E. Assist in monitoring the implementation of the Local Government Code on the matter of licensing of tourism establishment in the locality to ensure safe and enjoyable stay of travelers.

**Section 3. Meetings**

The Municipal Tourism Council shall meet once in every quarter or as often as maybe necessary to tackle issues and concerns related to the promotion and development of tourism.

**Section 4. Secretariat**

The Secretariat shall provide technical assistance and document minutes of meetings.

The Municipal Planning and Development Coordinator (MPDC) shall head the secretariat of the Council. She shall be assisted by the personnel of the Mayor's Office in the performance of her duties and functions.

**Section 5. Effectively**

This Executive Order shall take effect immediately this 16<sup>th</sup> day of May 2018 in the Municipality of Bayambang, Province of Pangasinan.
