CREATION OF FIVE-MAN COMMITTEE IN CONNECTION WITH THE PLANNING AND DEVELOPMENT OF THE BALON BAYAMBANG MUSUEM

WHEREAS, in pursuant to the Executive Order No. 044 series of 2017, as stated, the Local Government of Bayambang desires to bring out the aesthetic importance of the historical heritage of the Municipality of Bayambang through a museum to be called Balon Bayambang Museum;

WHEREAS, the creation of this committee is for the purpose of focusing on the collection of artifacts and contents of the museum; the planning and execution of the construction of the said Museum;

NOW THEREFORE, I, DR. CEZAR T. QUIAMBAO, Municipal Mayor of the Municipality of Bayambang, Province of Pangasinan, by virtue of the powers vested in me by law, do hereby approve and order the creation of Five-Man committee in connection with the planning and development of the Balon Bayambang Museum with members representing both the private and government sectors of this municipality under the following guidelines;

Section 1. Composition. The Five-Man Committee shall be composed of the following

Section 2. Functions. The Five-Man Committee shall:

- 2.1 Focus on the Planning and Execution of the creation of the Museum
- 2.2 To access feasible research studies on how to successfully execute such creation of Museum like on what to properly display, design of the building among other matters.
- 2.3 Collect and gather artifacts, historical and cultural accounts, old images and other materials regarding the early demographic and psychographic that would show the beauty of the history in related to the Municipality of Bayambang;

Section 3. Meetings

The Five-Man Committee shall meet every First Thursday of the month or as often as necessary to tackle concerns and issues related to the tasks and objectives set forth in the early portion of this paper.

Section 4. Secretary of the Committee

The Secretary to the council shall provide assistance and record the minutes of the meeting.

Jirah Junio shall head the secretariat of the Committee. She shall be assisted by all members in the performance of duties and functions.

Section 5. Effectivity.

This Executive Order shall take effect immediately.

All orders, rules and regulations, issuances or any part of coming from this office that is inconsistent with this order are hereby repealed, amended or modified accordingly.
