## EXECUTIVE ORDER NO. 026

#### ESTABLISHMENT OF LOCAL YOUTH DEVELOPMENT OFFICE (LYDO) AND DESIGNATION OF YOUTH DEVELOPMENT OFFICER

**WHEREAS**, Republic Act No. 10742, otherwise known as the Sangguniang Kabataan (SK) Reform Act of 2015 and its Implementing Rules and Regulations, provides for the creation of a Youth Development Office in every province, city and municipality;

**WHEREAS**, the said law states that the LYDO shall be headed by a Youth Development Officer with the rank of at least division chief;

**WHEREAS**, DILG Memorandum Circular No. 2017-36 dated February 24, 2017, provides the guidelines for the establishment of LYDO and designation of Youth Development Officer;

**NOW, THEREFORE, I, DR. CEZAR T. QUIAMBAO**, Municipal Mayor of Bayambang, Pangasinan, by virtue of the powers vested in me by law, do hereby designate **MR. JOHNSON R. ABALOS** as **Youth Development Officer**, and hereby create the **Local Youth Development Office (LYDO)**.

**Section 1. FUNCTIONS.** The LYDO shall:

1. Conduct mandatory training and continuing training of SK officials and LYDC members;
2. Spearhead training programs intended for the youth; and
3. Coordinate youth-related activities designed and implemented by the National Youth Commission (NYC) and the Department of Interior and Local Government.



**Section 2. LYDO FUNDING.** Pursuant to Section 26 of RA 10742, The Local Government shall incorporate in its annual budget such amount as may be necessary FOR THE OPERATION AND EFFECTIVE FUNCTIONING OF THE Local Youth Development Office.

**Section 3. SUPERVISION OVER LYDO.** Pursuant to Section 25 of RA 10742, the Youth Development Officer can be lodged under the Office of the Local Chief Executive (LCE). As such, the LCE shall exercise supervision over the LYDO operations and activities.

In our effort to maximize our resources, and considering the integral role of the youth in the development of Bayambang and in the fight against poverty, Mr. Johnson R. Abalos is likewise assigned to the Office of the Municipal Administrator (Anti-Poverty Office) as sectoral focal person/area coordinator/technical assistant, concurrent to his position as Local Youth Development Officer.

**Section 4. CREATION OF THE LOCAL YOUTH DEVELOPMENT COUNCIL (LYDC).** To ensure wide and multi-sectoral youth participation in local governance, a Local Youth Development Council (LYDC) is hereby created. The LYDC shall be composed of representatives of youth and youth-serving organizations in the municipality of Bayambang. The LYDC shall be composed of representatives of youth and youth-serving organizations in the municipality of Bayambang. The LYDC shall assist the planning and execution of projects and programs of the Sangguniang Kabataan, and the Pederasyon in all levels.

**Section 5. Effectivity.** This Executive Order shall take effect immediately.
