EXECUTIVE ORDER NO. 027 Series of 2018

AMENDMENT TO EXECUTIVE ORDER NO. 047 REORGANIZATION OF THE PROJECT MONITORING COMMITTEE (PMC) OF THE MUNICIPALITY OF BAYAMBANG, PANGASINAN

WHEREAS, DILG Memorandum Circular No. 2007-78 dated 18 July 2016 enjoins local government units to organize/reconstitute the Project Monitoring Committees (PMCs) in the local government units;

WHEREAS, the Department of the Interior and Local Government (DILG) Memorandum Circular (MC) 2004 – 78 dated June 22, 2004 directs the activation/reorganization of the Local Project Monitoring Committee to facilitate project implementation and devolve facilitation, problem solving, monitoring and evaluation of foreign, national and locally – funded projects to the sub-national levels;

WHEREAS, there is a need for proper monitoring of implemented projects under the Assistance to Municipalities FY 2018 of the Municipality of Bayambang, Pangasinan;

NOW THEREFORE, I, CEZAR T. QUIAMBAO, Municipal Mayor of Bayambang, Pangasinan, by virtue of the powers vested in me by law, do hereby reorganize and mobilize the Project Monitoring Committee in the Municipality of Bayambang:

SECTION 2. FUNCTIONS: The Local Project Monitoring Committee shall:

1. Provide and schedule of all projects to be monitored to NGOs involved in project monitoring;
2. Monitor and evaluate national-funded projects including development projects funded from the Internal Revenue Allotment (IRA) share of the Local Government Units (LGUs) or supported by funds released directly to the municipality,
3. Pinpoint problem and verify information to be submitted for analysis and action of the development council;
4. Provide feedback on the remedial actions of the development council and follow up their implementation; and
5. Project funded from the locally generated resources which are implemented within the respective areas.


SECTION 3. Effectivity.
