EXECUTIVE ORDER NO. 46 AUTHORIZING THE TRANSFER OF FUNDS UNDER THE OFFICE OF THE MUNICIPAL MAYOR- EXECUTIVE SERVICES

WHEREAS, the amount left under accounts MAYOR'S OFFICE CAPITAL OUTLAY (INFRASTRUCTURE PROJECTS-SLAUGHTERHOUSE) and SPECIAL ECONOMIC ENTERPRISE CAPITAL OUTLAY (INFRASTRUCTURE PROJECTS-SLAUGHTERHOUSE) are not sufficient to meet the obligations under the said account;

WHEREAS, the total amount of **ONE MILLION ONE HUNDRED NINETY TWO THOUSAND TWO HUNDRED SEVENTEEN AND 70/100 PESOS (P 1,192,217.70)** is available to augment the balance under accounts MAYOR'S OFFICE CAPITAL OUTLAY (FURNITURES AND FIXTURES) and SPECIAL ECONOMIC ENTERPRISE CAPITAL OUTLAY (PA SYSTEM);

NOW THEREFORE, I CEZAR T. QUIAMBAO, by virtue of the powers vested in me by law as the Local Chief Executive, do hereby authorize Municipal Budget Officer Peter B. Caragan to transfer the total amount of **ONE MILLION ONE HUNDRED NINETY TWO THOUSAND TWO HUNDRED SEVENTEEN AND 70/100 PESOS (P 1,192,217.70)**

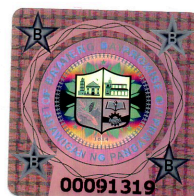
