



EXPLANATORY NOTE:

WHEREAS, the Sangguniang Bayan of Bayambang, Pangasinan submitted its Municipal Ordinance No. 10, Series of 2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Local Finance Committee, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 76 and 447 (a)(1)(viii) of R.A. 7160;

WHEREAS, the same Committee found that the position of Disability Affairs Officer is not included in the Index of Occupational Services, and thus, was ordered to be changed to any related position under the Office of the Municipal Social Welfare Officer and to which the Sangguniang Bayan of Bayambang, Pangasinan decided to comply with:

NOW THEREFORE, on motion of SB Member Benjamin Francisco S. De Vera, duly seconded;

Be it enacted by the Sangguniang Bayan in session assembled that:

SECTION 1. The position of Disability Affairs Officer shall be changed to Social Welfare Officer I under the Office of the Municipal Social Welfare Officer.

SECTION 3. The position shall have the following duties, power and functions:

OFFICE OF THE MUNICIPAL SOCIAL WELFARE

Social Welfare Office I (Item No. XIV-6)

1. Conducts intake interviews and accomplishes intake sheet;
2. Prepare Social case study report, transfer and closing Summary Reports;
3. Conducts collateral interviews and home visitations;
4. Conduct counselling, casework services and group sessions;
5. Coordinates with GOs, NGOs, and other POs, for support services needed by resident;
6. Maintains and updates recording/progress reports of residents;
7. Submit monthly status of cases of residents;
8. Prepares and escorts minors in attending court hearings;
9. Facilitate the reintegration/reunification of minors to their respective families/relatives;
10. Attend/participates in the Monthly General staff Meeting, Case Conference and Supervisory Conferences;
11. Submit reports regularly;
12. Perform other related tasks.


SECTION 4. EFFECTIVITY- This Ordinance shall take effect upon approval.
