CREATION OF COMMITTEE FOR EMERGENCY RELIEF AND PROTECTION OF CHILDREN BEFORE DURING AND AFTER DISASTERS AND OTHER EMERGENCY SITUATIONS

WHEREAS, under Section 2 of Republic Act 10821, it is declared the policy of the State to protect the fundamental rights of children before, during, and after disasters and other emergency situations when children are gravely threatened or endangered by circumstances that affect their survival and normal development. Guided by the principles on survival and development, on child participation, and consistent with the United Nations Convention on the Rights of the Child, as well as the Children's Charter for Disaster Risk and Reduction, and the minimum standards for children in humanitarian action, the State shall establish and implement a comprehensive and strategic program of action to provide the children and pregnant and lactating mothers affected by disasters and other emergency situations with utmost support and assistance necessary for their immediate recovery and protection against all forms of violence, cruelty, discrimination, neglect, abuse, exploitation and other acts prejudicial to their interest, survival, development and well-being.

WHEREAS, there is a need to Create a Response Committee for Emergency Relief and Protection of Children before, during and after disasters and other emergency situations.

NOW THEREFORE, I DR. CEZAR T. QUIAMBAO, Municipal Mayor of Bayambang, Pangasinan, by virtue of the powers vested in me by law as Local Chief Executive, do hereby create and designate the **COMMITTEE FOR EMERGENCY RELIEF AND PROTECTION OF CHILDREN BEFORE DURING AND AFTER DISASTERS AND OTHER EMERGENCY SITUATIONS** in the Municipal Government of Bayambang.

SECTION I. COMPOSITION: The Response Committee for Emergency Relief and Protection of children for Disasters and other Emergency Situation shall be composed of the following:

SECTION 2. FUNCTIONS.

1. Prepare, Plan and Formulate Policies plans and programs for a Comprehensive Emergency Program for Children which shall be immediately implemented after the declaration of a national or local state of calamity or occurrence of any other emergency situation.
2. Prepare, Plan and Formulate and adopt a child protection policy before during and after the occurrence of disasters and other emergency situations.
3. Prioritize the establishments and functionality of the barangay violence against women and children (VAWC) desks, which shall serve as one of key reporting and referral mechanism for cases of violence, abuse, and exploitation of children in the barangay diming all phases of emergency response and recovery.
4. Identify Establish and set-up child-friendly spaces in the municipality under a state of calamity, as needed, based on the guidelines to be promulgated by the DSWD. In addition, the Committee shall coordinate with lead agencies and CSOs to effectively respond to the needs of the children in the area. Child-friendly spaces shall be made available throughout a crisis, from emergencies to recovery.
5. Monitor and ensure the safety and the security of the affected children in the areas declared under a state of calamity and shall protect them from all forms of abuse and exploitation.

SECTION 3. MEETINGS.


The Committee shall meet and convene twice a year to plan and review its programs. The Committee shall conduct special meetings as needed. During Disasters, the committee shall meet within seventy-two (72) hours after the occurrence of disasters or other emergency situations.

SECTION 4. EFFECTIVITY.

This Executive Order shall take effect immediately.

Let copies of this order be furnished to the Department of Interior Local Government (DILG), Office of Civil Defense (OCD) and those concerned.
