

EXECUTIVE ORDER NO. 44 Series of 2019



"AN ORDER IMPLEMENTING SANGGUNIANG BAYAN RESOLUTION NO. 330 SERIES OF 2019 OF THE SANGGUNIANG BAYAN OF BAYAMBANG, PANGASINAN FOR PREVENTIVE SUSPENSION OF SIXTY (60) DAYS AGAINST PUNONG BARANGAY ZENAIDA B. CAMACHO, BARANGAY KAGAWAD ALEX BARROGO and BARANGAY KAGAWAD ROLANDO JUSTO OF BARANGAY BUAYAEN THIS MUNICIPALITY, PURSUANT TO SECTION 63 OF REPUBLIC ACT 7160 OTHERWISE KNOWN AS THE LOCAL GOVERNMENT CODE OF 1991"

WHEAREAS, an Administrative Complaint against Punong Barangay Zenaida B. Camacho, Barangay Kagawad Alex Barrogo and Barangay Kagawad Rolando Justo was filed by Eva Ferrer Pinto, Christian Pinto a.k.a. "Lopin" and Christopher Pinto a.k.a. "Baldo" and is docketed as Administrative Case No. 06-2019 for GRAVE MISCONDUCT and OPPRESSION;

WHEREAS, SB RESOLUTION No. 330 Series of 2019 imposed Preventive Suspension for a period of sixty (60) days against Punong Barangay Zenaida B. Camacho, Barangay Kagawad Alex Barrogo and Barangay Kagawad Rolando Justo in furtherance of the investigation in the said administrative case;

WHEREFORE, upon recommendation of Sangguniang Bayan of Bayambang, Pangasinan as embodied in SB Resolution No. 330 series of 2019 carried in its regular session on October 14, 2019, I, CEZAR T. QUIAMBAO, by virtue of the powers vested in me by law and the Local Government Code of 1991, do hereby direct and order:

Section 1. Placing under preventive suspension from office Punong Barangay Zenaida B. Camacho, Barangay Kagawad Alex Barrogo and Barangay Kagawad Rolando Justo of Barangay Buayaen, Bayambang, Pangasinan for a period of Sixty (60) days effective upon service of this order.

Section 2. The law on succession as provided under the Local Government Code of 1991 shall apply.
