AN ORDER AMENDING EXECUTIVE ORDER NO. 45, SERIES OF 2019 ENTITLED, "AN ORDER DECLARING A TEMPORARY BAN ON ENTRY AND EXIT OF LIVE PIGS, FRESH AND FROZEN PORK INTO AND OUT OF THE MUNICIPALITY OF BAYAMBANG"

WHEREAS, Executive Order No. 45, Series of 2019 was issued on **October 19, 2019** to prescribe basic policies and guidelines to effect the strict implementation of the temporary prohibition of the entry and exit of live pigs, fresh and frozen pork with the purpose of containing the spread of ASF not only in the Municipality of Bayambang, but also to other areas of the province, thereby protecting the livestock industry and related businesses from any possible economic losses and to further advance the health and safety of the people;

WHEREAS, the Department of Agriculture issued policies, regulations and guidelines to address ASF-related issues and to contain and control the spread of the dreaded hog disease within the country;

WHEREAS, Section 444 (b) (2) (iii) of Republic Act No. 7160 otherwise known as the **Local Government Code of 1991** provides that the Municipal Mayor has the power to issue such executive orders for the faithful and appropriate enforcement and execution of laws and ordinances;

NOW THEREFORE, by the power and authority vested in me by law, **I, CEZAR T. QUIAMBAO,** Municipal Mayor of the Municipality of Bayambang, do hereby order:

SECTION 1. Article II. Prohibited Acts of Executive Order No. 45, Series of 2019 is hereby amended to read as follows:

ARTICLE II. PROHIBITED ACTS AND EXEMPTIONS

Prohibition. The transport of live pigs, fresh and frozen pork to and from the Municipality of Bayambang is strictly prohibited.

Exemptions. The transport of live pigs, fresh and frozen port to and from the Municipality may be allowed if and when accompanied by the necessary documents and permits and subject to the guidelines Issued by the Department of Agriculture under the following administrative orders and memorandum circulars:

A. Department of Agriculture Administrative Order No. 7. Series of 2019 dated September 9, 2019 **(VETERINARY QUARANTINE MOVEMENT PROTOCOL DURING ANIMAL DISEASE OUTBREAKS/ EMERGENCIES);**

B. Department of Agriculture Administrative Order No. 8. Series of 2019 dated September 9, 2019 **(REVISED GUIDELINES ON THE LOCAL MOVEMENT OF SWINE. PORK. PORK PRODUCTS AND PORK BY-PRODUCTS OUTSIDE DISEASE OUTBREAK AREAS,** which states that “All swine commercial farms will be allowed to move, provided they have presented the documents in designated Animal Quarantine Checkpoints in the disease outbreak areas:

a. For Breeder Animals:

- i.** Veterinary Health Certificate (VHC) issued by a duly LICENSED VETERARIAN whether employed in the government or private practice
- ii.** Negative Laboratory Test Results of different swine disease
- iii.** BAI Certificate of Laboratory Compliance (as written in DA AO 13 Series of 2012)
- iv.** BAI Livestock Handlers’ License
- v.** BAI Livestock Carrier Certificate
- vi.** Shipping Permit issued by the Bureau of Animal Industry (valid within 7 days after its date of issuance)

b. For live animals to be brought to the slaughterhouse:

- i.** Veterinary Health Certificate (VHC) issued by a duly LICENSED VETERARIAN, if the signatory is a farm veterinarian, the VHC should be concurred by a government veterinarian (provincial, city or municipality)
- ii.** Shipping Permit issued by the Bureau of Animal Industry (valid within 7 days after its date of issuance)
- iii.** BAI Livestock Handlers’ License
- iv.** BAI Livestock Transport Carrier Certificate
- v.** Updated BAI Farm Accreditation

c. For newly slaughtered, frozen, raw, fresh meat:

i. For locally produced meat and meat products

- Shipping Permit issued by the Bureau of Animal Industry (valid within 7 days after its date of issuance)

C. Department of Agriculture Administrative Order No. 10, Series of 2019 dated September 25, 2019 (**GUIDELINES IN THE MOVEMENT OF LIVE ANIMALS FROM SWINE FARMS WITHIN THE 1 KM ZONE OF AFRICAN SWINE FEVER (ASF) AMENDING 1-7-10 PROTOCOL IN INFECTED AREAS**); and

D. Department of Agriculture Memorandum Circular No. II, Series of 2019 dated September 26, 2019 (**SUPPLEMENTAL PROCEDURES IN THE SLAUGHTER OF SWINE AND MOVEMENT OF ITS MEAT AND BY-PRODUCTS DURING ANIMAL DISEASE OUTBREAKS/ EMERGENCIES**)

However, canned goods and processed pork products may be transported, as long as the same is authorized by the FDA and other concerned government agencies;

2) Hotels, Restaurants, Eateries, Cafeterias, Canteens, Fast Chains, and other food establishments shall be prohibited from selling or giving their leftovers or spoiled food to hog raisers. Hence, in case of violation thereof, the concerned LGU shall revoke the business of said establishment. Purchasers and/or recipients of leftovers as discussed in the preceding paragraph shall be dealt with in accordance with law.

3) The feeding of swill or food wastes to the pigs in the Province is strictly prohibited.

SECTION II. EFFECTIVITY.

This Executive Order shall take effect immediately and will continue until amended or revoked.
