#### AN EXECUTIVE ORDER CREATING A TASK FORCE FOR SEVERE CONTAGIOUS HUMAN DISEASES

**WHEREAS**, communicable diseases constitute most of the leading cause of morbidity and mortality in the Philippines;

**WHEREAS**, the control of communicable diseases is one of the government's priorities for national development in the field of health;

**WHEREAS**, a strong biomedical research component with full cooperation between academic institutions and field agencies is necessary for the effective pursuit of programs for the control of communicable diseases;

**WHEREAS**, immediately after the World Health Organization declared global emergency, the Inter-agency Task Force for the Management of Emerging Infectious Diseases approved and recommended the adoption of guidelines for the management of the 2019 Novel Coronavirus Acute Respiratory Disease Situation;

**WHEREAS**, there is an urgent need for the creation of a task force committee to be on a state of preparedness and take all proactive steps to stop the spread of a diseases.

**NOW THEREFORE, I, DR. CEZAR T. QUIAMBAO**, Municipal Mayor of the Municipality of Bayambang, Pangasinan, Philippines, by virtue of the power vested in me by law as the Local Chief Executive, do hereby create a task force, prescribing its functions and schedule of meetings.

7. Undertake research activities in the diagnosis, control, prevention of infectious diseases that are major causes of mortality and morbidity.
8. Conduct clinical trials aimed at better understanding and control of diseases.
9. Conduct regular training courses for medical and paramedical personnel in the control of diseases.
10. Apply for, receive, and accept bequests, grants, and donation of funds, equipment, materials and services needed for attainment of its objectives.

### Section III. ORGANIZATION AND PERSONNEL

The committee shall also have its technical and administrative support staff as well as consultants as may be necessary. Such consultants may be drawn from the public and private sectors on consultancy or contractual basis and shall be granted honoraria or allowances at such amounts as may be determined in accordance with existing rules and regulations.




