REORGANIZATION/RECONSTITUTION OF THE LOCAL COUNCIL FOR THE PROTECTION OF CHILDREN (LCPC)

WHEREAS, pursuant to Department of the Interior and Local Government (DILG) Memorandum Circular No. 2002-121 dated August 5, 2002, Local; Government Units are encouraged to organize their respective Local Council for the Protection of Children (LCPC) per provisions of Presidential Decree 603 as mandated on Republic Act 8990, will shall be responsible in planning and spearheading programs for children in the locality with the end view of making the locality child-friendly;

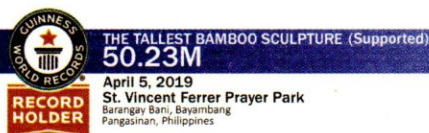
WHEREAS, Republic Act No. 7160, the Special Protection of Children Against Child Abuse, Exploitation and Discrimination Act provides for stronger deterrence and special protection against child abuse, exploitation and discrimination, and its corresponding penalties;

NOW THEREFORE, I, DR. CEZAR T. QUIAMBAO, Municipal Mayor of the Municipality of Bayambang, Province of Pangasinan, and by virtue of the powers vested in me by law, do hereby order and direct the following:
