EXECUTIVE ORDER No. 20
Series of 2020

**“LIMITING THE OPERATING HOURS OF AND DECLARING A PUBLIC
MARKET HOLIDAY IN THE BAYAMBANG PUBLIC MARKET
LOCATED IN BARANGAY ZONE I”**

WHEREAS, Proclamation No. 929 series of 2020 of the President of the Philippines declared a State of Calamity throughout the Philippines due to Corona Virus Disease 2019 (CoViD-19);

WHEREAS, Proclamation No. 922 series of 2020 was issued declaring a State of Public Health Emergency throughout the Philippines due to CoViD-19, enjoining all government agencies and local government units (LGUs) to render full assistance and cooperation and mobilize the necessary resources to undertake critical, urgent and appropriate response and measures in a timely manner and eliminate the threat of CoViD-19;

WHEREAS, the President of the Philippines imposed an Enhanced Community Quarantine throughout Luzon beginning 12 midnight, March 16, 2020 limiting the movement of the people and imposing the implementation of home quarantine except to buy food and medicine;

WHEREAS, despite government interventions, the number of confirmed cases of CoViD-19 continues to rise;

WHEREAS, a resident of the Municipality was announced by the Department of Health to have died due to CoViD-19 on March 20, 2020. The Provincial Health Office relayed the need for an immediate strict implementation of the Enhanced Community Quarantine, Border Lockdown, and the Lockdown of Affected Barangays;

WHEREAS, there is a need to restrict the movement of the people and to fully sanitize the Public Market of Bayambang and to undertake the necessary measures to curtail and eliminate the clear and present danger;

NOW THEREFORE, I, RAUL R. SABANGAN, by virtue of the powers vested in me by law as the Acting Municipal Mayor, do hereby **LIMIT THE OPERATING HOURS OF THE BAYAMBANG PUBLIC MARKET LOCATED IN BARANGAY ZONE I, TO WIT:**

SECTION 1. LIMITING THE OPERATING HOURS OF THE PUBLIC MARKET. The operating hours of the Bayambang Public Market is hereby limited from **Seven o'clock up to Eleven o'clock in the Morning (7AM-11AM) and Three o'clock up to Six o'clock in the afternoon (3PM-6PM) from March 21 to March 22, 2020 and on March 26, 2020.** This is to give way for the Sanitation of the Public Market every time it is closed.

SECTION 2. DECLARING A PUBLIC MARKET HOLIDAY. Due to the Enhanced Community Quarantine, the Bayambang Public Market will be closed to the Public on **March 23-25, 2020 and on March 27-28, 2020** to limit the number of people going out of their houses. However, all convenience stores, sari-sari stores and community markets shall remain open provided that the people patronizing them observe social distancing and not to loiter around longer than needed.

SECTION 3. IMPLEMENTATION. The Office of the Market Supervisor in coordination with the Public Order and Safety Office (POSO) and the Philippine National Police shall see to it that no stalls in the Bayambang Public Market shall open on the above-mentioned date. The same office is also directed to thoroughly conduct sanitation clean up drives and disinfection of the Bayambang Public Market during the Market Holiday.


SECTION 4. Separability Clause. If any provision of the Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

SECTION 5. Repealing Clause. All other orders, rules, regulations and issuances, or parts thereof, which are inconsistent with this Order, are hereby repealed, amended or modified accordingly.

SECTION 6. Effectivity Clause. This Executive Order shall take effect immediately.

Let copies of this Order be furnished to Offices and Departments concerned for their information and guidance.
