EXECUTIVE ORDER No. 24

"DESIGNATING THE EVACUATION CENTERS IN BARANGAYS SAN GABRIEL 1ST AND MANAMBONG NORTE OF THIS MUNICIPALITY AS ISOLATION FACILITY FOR COVID-19 PERSONS UNDER MONITORING AND PERSONS UNDER INVESTIGATION AND SPECIAL CARE FACILITY, RESPECTIVELY"

WHEREAS, Memorandum Circular No. 2020- from Department of Interior and Local Government Secretary Eduardo M. Año laid down the "Suppletory Guidelines on the Implementation of Enhanced Community Quarantine in Luzon, and State of Public Health Emergency in Other Parts of the Country due to the CoViD-19 Threat;

WHEREAS, 5.1.1 of the Guidelines states that "All LGUs are charged with the promotion of health and safety within their jurisdiction. As such, they are to take the lead in the prevention and control of the spread of CoViD-19 at the local level.";

WHEREAS, 5.2.4 of the Guidelines states that "LGUs shall implement strict home quarantine. This shall be enforced by LGUs in all households within their jurisdiction. Movement shall be regulated through the issuance of gate passes to designated individuals per household. Further, such movement shall be limited to accessing basic necessities, and provision for food and essential health services";

WHEREAS, Memorandum Circular No. 2020-064 of the Department of Interior and Local Government mandates all provincial governors, city and municipal mayors to identify government facilities that may be temporarily converted into isolation and quarantine facilities. Also, Local Chief Executives are enjoined to identify, designate and establish their respective CoViD-19 special care facilities pursuant to Inter-Agency Task Force Resolution No. 16;

WHEREAS, to fully implement the said directive, there is a need to identify, designate and establish isolation, quarantine, and special care facilities;

NOW THEREFORE, I, RAUL R. SABANGAN, by virtue of the powers vested in me by law as the Acting Municipal Mayor, do hereby promulgate the DESIGNATION OF THE EVACUATION CENTERS IN BARANGAYS SAN GABRIEL 1ST AND MANAMBONG NORTE OF THIS MUNICIPALITY AS ISOLATION FACILITY FOR COVID-19 PERSONS UNDER MONITORING AND PERSONS UNDER INVESTIGATION AND SPECIAL CARE FACILITY, RESPECTIVELY, TO WIT:

SECTION 1. DESIGNATION OF THE EVACUATION CENTER IN BARANGAY SAN GARBIEL 1ST AS ISOLATON FACILITY OF PUMs AND





PUIs. The Evacuation Center located in Barangay San Gabriel 1st shall be the Municipal Isolation Facility for Person Under Monitor and Persons Under Investigation.

- a. With the influx of returning Bayambangueños coming from Metro Manila and other provinces, the facility will be their home until they completer the mandatory 14-day quarantine period. PUMs showing signs or symptoms of CoViD-19 shall remain in the facility until they recover or transferred to the special care facility.
- b. The Municipal Disaster Risk Reduction Management Office shall be primarily responsible for providing the needs of the facility.
- c. The Municipal Health Physician shall be primarily responsible for the staffing and attending to the PUMs' and PUIs' medical needs.
- d. The Public Order and Safety Office, in coordination and cooperation with the Philippine National Police Municipal Police Station. shall be responsible for the perimeter security of the facility.
- e. The Municipal Agriculture Office, in coordination and cooperation with the Bureau of Fire Protection Municipal Fire Station, shall be responsible in conducting periodic flushing and disinfection operation of the facility.
- f. The Municipal Health Physician is authorized, with the approval of the Local Chief Executive, to engage the services of additional medical personnel, including but not limited to the following: licensed physicians, registered nurses, medical aides or orderlies and facility security.

SECTION 2. DESIGNATION OF THE EVACUATION CENTER IN BARANGAY MANAMBONG NORTE AS SPECIAL CARE FACILITY OF PUIS SHOWING SEVERE SYMPTOMS OF COVID-19. The Evacuation Center located in Barangay San Gabriel 1st shall be the Municipal Isolation Facility for Person Under Investigation showing severe signs or symptoms of CoViD-19. PUMs and PUIs, including those in the San Gabriel 1st evacuation center, under this category shall be brought to this facility for intensive care.

- a. PUMs and PUIs showing severe signs or symptoms of CoViD-19 shall remain in the facility until they recover or transferred to another facility.
- b. The Municipal Disaster Risk Reduction Management Office shall be primarily responsible for providing the needs of the facility.
- c. The Municipal Health Officer shall be primarily responsible for the staffing and attending to the PUMs' and PUIs' medical needs.
- d. The Public Order and Safety Office, in coordination and cooperation with the Philippine National Police Municipal Police Station, shall be responsible for the perimeter security of the facility.
- e. The General Services Office, in coordination and cooperation with the Bureau of Fire Protection Municipal Fire Station, shall be responsible for the periodic flushing and disinfection operation of the facility.
- f. The Municipal Health Officer is authorized, with the approval of the Local Chief Executive, to engage the services of additional medical personnel, including but not limited to the following: licensed physicians, registered nurses, medical aides or orderlies and facility security.

SECTION 3. MANDATORY REPORTING OF PUMs and PUIs WITH SEVERE SYMPTOMS. The Barangay Health Emergency Response Teams shall be primarily responsible for the reporting to the Municipal Health Office of PUMs and PUIs showing signs or symptoms of CoViD-19 in their respective barangays. Households shall also report to the BHERTs any household member showing signs or symptoms. The Municipal Health Office, upon discretion, may bring the PUMs and PUIs to the designated facilities.

SECTION 4. VIOLATIONS. Any person who fails to report, notify or otherwise lie in reporting suspected CoViD-19 cases shall be held liable under Republic Act 11332.

SECTION 5. SEPARABILITY CLAUSE. If any provision of the Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

SECTION 6. REPEALING CLAUSE. All other orders, rules, regulations and issuances, or parts thereof, which are inconsistent with this Order, are hereby repealed, amended or modified accordingly.

SECTION 7. EFFECTIVITY. This Executive Order shall take effect immediately.

Let copies of this Order be furnished to Offices and Departments concerned, the Bureau of Fire Protection, the Philippine National Police and all Barangays for their information and guidance.
