**WHEREAS**, in compliance thereof, the Municipal Administrator is hereby authorized as the responsible officer, to countersign checks pursuant to said provision of law;

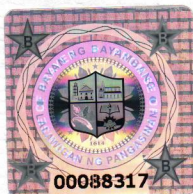
