**WHEREAS,** Section 345 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991, provides, to wit:

"SEC. 345. Official Authorized to Draw Checks in Settlement of Obligations.

**WHEREAS,** in compliance thereof, the Municipal Administrator is hereby authorized as the responsible officer, to countersign checks pursuant to said provision of law;

WHEREFORE, by virtue of the powers vested in me by law, I hereby authorize the Municipal Vice Mayor, Raul R. Sabangan, to countersign checks duly drawn by the Local Treasurer amounting to P200,000 and above, in accordance with prevailing rules and regulations in view of my physical absence. Said authority shall be automatically withdrawn upon my full assumption to discharge said duties.
